Overview of the Framework REMC Limited

REMC Limited on behalf of Indian Railways invites eligible Bidders to participate in the bidding process for "Implementation of grid connected rooftop solar PV system at office building/ Railway stations & other establishments of MCF with the objective of generating and supplying energy to appropriate Railway installations".

REMC Limited is a Joint Venture (JV) company of Indian Railways and RITES Ltd hereinafter referred to as "REMCL" or "Authorized Representative", having its registered office at Core-1, 12th Floor, SCOPE Minar, Laxmi Nagar, Delhi-110 092 and Corporate office at RITES Bhawan, Ground Floor, Central Wing, Plot No. 1, Sector-29, Gurgaon-122 001. Currently operating from REMC LTD,8th Floor PNB Building, 7, Bhikaji Cama Place, New Delhi-110066.

All the activities related to bid processing management starting from Uploading/Publishing of NIT/ RFQ/RFP/PPA till award of LOA to successful bidders will be done by REMCL on behalf of MCF/Indian Railways. Thereafter all activities related to execution of work will be carried out by MCF, including the Power Purchase Agreement signed with the respective developers. REMCL will act as the Bid Process Co-ordinator and manage the bid centrally on behalf of MCF. REMCL's responsibility will cease after issue of LOA. REMCL does not hold any responsibility in case of any dispute or litigation arises in PPA and execution of work after issuance of LOA by REMCL.

The bidding process will be a single stage two packet centralized process carried out by REMCL on behalf of MCF without any Subsidy/Viability Gap Funding (VGF) support from MNRE or Railways. The bid document comprises of RFQ, RFP and PPA. The bidders will submit one bid package for MCF comprising of the technical and commercial qualification with supporting documents corresponding to the requirements of Request For Qualification(RFQ) and a price bid corresponding to the requirements of Request For Proposal(RFP), on Bharat tender e-portal (https://www.bharat-electronictender.com) on or before the Bid due date.

Note: - Interested bidders have to download the official copy of RFQ & other documents after logging into the Bharat tender e-portal (https://www.bharat-electronictender.com) by using the Login ID & Password provided by Bharat tender during registration. The bidder shall only be eligible to submit/ upload the bid document only after logging into Bharat tender e-portal (https://www.bharat-electronictender.com) and downloading the official copy of Bid document.

The bidder is required to submit one consolidated bid and indicate the capacity offered for MCF where it proposes to sell power (Annexure-VI). The bidder may quote for MCF. Bids for part capacity would be rejected.
