REMCL will evaluate the bids based on the technical and financial eligibility illustrated under clause 2.2.2 (A) and 2.2.2 (B), of this RFQ document.

"Only those bidders who meet the technical and financial eligibility, under this stage (RFQ stage) will have their price bids opened by the REMC Limited (REMCL)". After Evaluation of Technical Bids (RFQ) and Price bids (RFP), the eligible bidders shall be invited for e-reverse auction. The qualified bidders at RFP stage who has quoted the lowest tariff during Reverse Auction for MCF, would be declared as a successful bidder for MCF.

CFA (Central Finance Assistance)

The present tender is without CFA & as such no CFA will be payable either by MNRE or Railways.

Request for Qualification (RFQ)

The RFQ aims to identify credible bidders who have the requisite technical and financial capacity for undertaking the project. The information sought for the purposes of pre-qualification should generally be restricted to technical and financial capabilities that are relevant to the project. Such information should be precise and quantified so that the process of short-listing is fair and transparent, and does not expose the government to disputes or controversies. The bidders, who meet the technical and financial qualification requirements will be shortlisted and announced by the REMC Limited (REMCL). The shortlisted bidders will then be invited for the opening of the price bids & the eligible bidders thereof shall participate in Reverse Auction process. Thereafter the results of successful bidders will be announced by the REMCL. The RFQ document is provided with the list of MCF/Railways and their capacities in the Annexure-VII.

Technical Capacity

For demonstrating technical capacity and experience (the "Technical Capacity"), the Bidder shall, over the past 3 (three) financial years (i.e. current year and three previous financial years) preceding the Bid Due Date, have paid for, or received payments for successful commissioning of at least 100 kWp at single location for a minimum value of 35% of the offered Capacity; The list of projects commissioned along with a copy of the Commissioning Certificate, Bills and Invoices demonstrating payment received for such commissioning works and Work order / Contract / Agreement from the Client/Owner shall be submitted in support. Financial Capacity

Total contract amount received or paid in rupees during the last 3 financial years (i.e. current year and three previous financial years) preceding the Bid Due Date as per duly certified audited annual financial statements should be a minimum of 150% of the Estimated Project Cost. Please refer the Illustration under 2.2.2 (B)

Request for Proposal (RFP)

The qualified bidders at RFQ stage shall be called for the opening of the price bids & to participate in e-Reverse Auction process. The results of the bid will be announced by the REMCL, after selection of the successful bidder through e-reverse auction. REMCL on behalf of MCF will issue the Letter of Intent/Letter of Award to the successful bidders.

Signing of Power Purchase Agreement:

The successful bidder is required to sign Power Purchase Agreement (PPA) for period of 25 years with the MCF for which it is issued the Letter of Award. The bidder may also be required to sign the PPA at Divisional level, if required by MCF/PUs/Zonal Railways.
