NOTICE OF TENDER IN LIEU OF IAFW-2162 (REVISED 1960)

OF

- 1. A tender of the type as mentioned in Appendix-'A' to this Notice of Tender is invited for consultancy services for concluding contract as per particulars given therein.
- 2. The estimated cost of the project for which consultancy services are required is as indicated in the aforesaid Appendix-'A'. These estimates however are not a guarantee and are merely given as a rough guide and if the work costs more or less, tenderer will have no claim on that account
- 3. Tender shall be accompanied by Earnest Money (for amount refer aforesaid Appendix-'A' or amendments thereafter) in the form of FDR / Banker's Cheque issued in favour of the GE (I) (P) No 2 Leh by a scheduled bank.
- 4. The consultancy and design work is to be completed within the period as indicated in the aforesaid Appendix-'A' from the date of handing over documents which may be about one week after the date of acceptance of the tender.
- **5.** Critical dates related to the tender are mentioned in the online portal.
 - **Note:** Submission of bid for tender on online portal does not constitute any guarantee for opening of the bid of the applicant. Opening of bid will be decided by the Accepting Officer based on prequalification (PQ) criteria as detailed in PQ documents. The Contractor will be informed regarding non-opening of tender.
- 6. Normally the Contractors whose names are on the MES approved list for the area in which the work lies and within whose financial category the estimated amount would fall may tender. But in case of term contracts, Contractors in category 'SS' to 'E' may tender. Not more than one tender shall be submitted by one Contractor, or one firm of Contractors. Under no circumstances will a father and his son(s) or other close relations who have business dealing with one another will be allowed to tender for the same contract as separate competitors. A breach ofthis condition will render the tender of both parties liable to rejection.
- 7. The tender shall be received online only by the GE (I) (P) No 2 Leh, Military Engineer Services, Near Zorawar Fort, Sakara Road, Leh- 194101 upto due date mentioned in the portal or as amended thereafter.
- **8.** The GE (I) (P) No 2 Leh will be the Accepting Officer hereinafter referred to as such for the purpose of this contract.
- 9. The Technical Bid and Financial bid (Cover-1 and Cover-2)shall be uploaded by the tenderer/bidder on or before the date & time mentioned in NIT. A scanned copy of DD with enlistment details/ documents shall be uploaded as packet 1) cover-1 ('T' bid) of the tender /bid on e-tendering portal. DD is refundable in case 'T' bid is not accepted resulting in non-opening of 'Q' bid. The applicant contractor shall bear the cost of bank charges for procuring and encashing the DD and shall not have any claim from Government whatsoever on this account.
- **10.** Tender forms and conditions of contracts and other necessary documents shall be availableon https://eprocure.gov.in site for download and shall formpart of contract agreement incase tender/bid is accepted.
- 11. In case of contractor who has not executed the Standing Security Bond, the cover-I shall be accompanied with by Earnest Money of amount as mentioned Appendix-'A' in the form of deposit at Call receipt in favour of concerned GE (see Appendix-A') by a Scheduled Bank or in receipted treasury Challan, the amount being credited to the revenue deposit of the concerned GE (see Appendix-'A').
- **12.** A Contractor who is not enlisted for the area in which the work lies, but whose name is in the MES approved list of any MES formation and who has deposited standing security and executed standing security bond may bid without depositing earnest money alongwith the tender.
- 13. The GE will return the Earnest Money wherever applicable to all unsuccessful tenderers/bidders by endorsing an authority on the deposit-at-call receipt for its refund, on production by the tenderer/bidder a certificate of the Accepting Officer that a bonafide tender/bid was received and all documents were returned.

14. The GE will either return the Earnest Money to the successful tenderer by endorsing on the deposit receipt for its refund on the deposit-at-call receipt for its refund on receipt of an appropriate amount of performance guarantee or will retain the same in part or full on account of performance if such a transaction is feasible.

- 15. Copies of the drawings and the documents pertaining to the work asigned for the purpose of identification by the Accepting Officer or his accredited representative, sample of materials and stores to be supplied by the Contractor will also be available for the inspection of tenderer/bidder at the office of Accepting Officer and concerned GE office during working hours.
- 16. The tenderers are advised to visit site by making prior appointment with the GE who is also the Executing Agency of the work (see Appendix-'Å'). Tenderers/bidders are deemed to have full knowledge of all relevant documents, samples, site, etc. whether they have inspected them or not.
- **17.** Any tender/bid which proposes any alternation to any of the conditions laid down or which proposes any other condition or prescription whatsoever, is liable to be rejected.
- 18. The uploading of bid implies that bidder has read this notice and the Conditions of Contract and has made himself aware of the scope and specifications of work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him and local conditions and other factors having bearing on the execution of the work.
- **19.** Tenderers/bidders must be in possession of a copy of the MES Standard Schedule of Rates (see Appendix-'Á') including errata and amendments thereto.
- 20. Invitation for e-tender does not constitute any guarantee for validation of 'T' bid and subsequent opening of financal bid of any applicant/bidder, even of enlisted contractors of appropriate class, merely by virtue of enclosing DD. Accepting Officer reserves the right to reject the 'T' bidand not open the finance bid of any applicant/bidder. 'T' bid validation shall be decided by the Accepting Officer based on, inter alia, capability of the firm as per criteria given in Appendix 'A' to this NIT. The applicant contractor/bidder will be informed regarding non validation of his 'T' bid assigning reasons thereof through the 'eprocuremes.gov.in'website. The applicant contractor/bidder if he so desires may appeal to the next higher Engineer Authority namely viz. HQ Chief Engineer Leh on email' with copy to the Accepting Officer on email before the scheduled date of opening of finance bid. The decision of the Next Higher Engineer Authority (NHEA) shall be final and binding. The Contractor/bidder shall not be entitled for any compensation whatsoever for rejection of his bid.
- 21. The Accepting Officer reserves his right to accept tender submitted by a Public Undertaking giving price preference over other tenders, which may be lower as are admissible under the Government policy. No claim for any compensation or otherwise shall be admissible from such tenderers whose tenders may be rejected on account of the said policy.

22. The Consultant shall be disqualified if :-

- (a) The Consultant has been blacklisted / banned for business dealings for all Government-Departments or by the Ministry of Defence, DG or by the MES at any time till finalization of-proposals, except in cases where such blacklisting / banning has been withdrawn by the-Competent Authority or has ceased on the deadline for submission of the proposals, for which-satisfactory-evidence is-to be produced.
- (b) Any previous contract of-the-Consultant-had-been-terminated-due-to-Consultant's-failure-by the Director General Married Accommodation project (DG MAP / MES), at any time-starting-from-2-years-before-the-deadline-for-submission-of-proposals, provided, -there-is-no-stay-order-or declaration by any Court against such termination of the Contract by the DG / MES or such termination of the Contract has been revoked by the DGMAP/MES.
- (c) The Consultant has suffered bankruptcy/insolvency or it is in the process of winding-up or there is a case of insolvency pending before any Court on the deadline of submission of proposals or thereafter till finalization of proposals.
- (d) The Consultant has been declared by the DG MAP / MES to be a poor performer and the period of poor performance is still in force on the deadline for submission of proposals.
- **23.** The Consultant shall submit an affidavit that they are not liable to be disqualified on account of clauses mentioned above.

- **24.** The following affidavit/documents of bidder(s)shall be uploaded:

 - (b) Experience and Degree/ Diploma certificates of Engineers and Architects

The bidder's bid shall not be considered for tender for the works in entire area under whose control his/their near relatives are working as Gazetted / Commissioned Officer
- (e) Affidavit of sister concern firm and that no foreign national has been appointed
- (f) Affidavit of annual turnover along with certificate from CA with supporting documents for last 2 years.
- (g) Details of work/executed in the past 3 years
- (h) DD & EMD as applicable and as detailed
- (j) Any other documents as required
- (k) Enlistment letter of MES as applicable
- (I) Documents as per paras 2,6to 11of serial page Nos.9&10 of these tender documents

Notes:

- (i) All affidavits shall be given on non-judicial stamp paper of Rs 100/- duly signed by authorized bidder and attested by the Magistrate/Notary public.
- (ii) All the document uploaded by bidder shall be signed by authorized representative of firm.
- **25.** The bidder shall upload the following documents in support of character and antecedents:
 - (a) The certificate of character and antecedents of the Proprietor(s)/Partner(s)/Director(s) and their agents affixed with photograph(s) and signed by appropriate authority not below the rank of SP of the district to which the individual belongs or copy of valid passport of Proprietor(s)/Partner(s)/Director(s)and their agents.

Notes:

- (i) If the bidder made misleading or false representation or deliberately suppress information in the form, affidavits, statements and enclosures required in the prequalification documents, the bid shall be rejected and the firm shall be banned for 5years in MES and DG MAP
- (ii) In absence of above documents bidder(s)shall be disqualified.
- (iii) Hard copy of these documents shall be submitted within 7 days of bid submission end date.
- 26. The Department reserves the right to physically verify the performance of the Consultant in work is already finished / being executed and other details furnished by the Consultant. The Department also reserves the right to reject any prospective application without assigning any reason and restrict the list of pre-qualified Consultants to any number as deemed fit.

27. PERFORMANCE GUARANTEE & SECURITY

- (a) Within 28days of receipt of the letter of acceptance, the successful contractor shall deliver to the Accepting Officer a performance security in any of the forms given below for an amount equivalent to 3% of the contract sum.
- (b) A bank guarantee in the prescribed form.
- (c) Government Securities, FDR or any other government instruments stipulated by the Accepting Officer.
- (d) If the performance security is provided by the successful contractor in the form of a Bank Guarantee, it shall be issued by Nationalized/Scheduled Indian Bank, but it's confirmation shall be done only from the Head Office of the bank.
- (e) Failure of the successful Contractor to comply with the requirements of clause 27.1 shall constitute sufficient grounds for cancellation of the award of work and forfeiture of the Earnest Money. In case of MES enlisted Contractor, amount equal to the Earnest Money stipulated in the Notice Inviting Tender, shall be notified to the tenderer for depositing the amount through MRO. Issue of tender to such tenderers shall remain suspended till the aforesaid amount equal to the Earnest Money is deposited in Government Treasury.

- (f) All compensation or other sums of money payable by the Contractor to the government under the terms of this contract or under any other contract with government may be deducted from, or paid by the sale of a sufficient part of the performance security or from the interest arising there from or from any sums which may be due or become due to the contractor by the government on any account whatsoever and in the event of his performance security being reduced by reason of any such deduction, or sale as aforesaid, the contractor shall within ten days thereafter make good in cash or securities, endorsed as aforesaid any sum or sums which may have been deducted from or realized by the sale of his performance security or any part thereof. Government shall not be responsible for any loss of securities or any depreciation in the value of securities while in their charge nor for loss of interest thereon.
- (g) In the event of contract being cancelled, under conditions 52, 53 & 54 of General Conditions of Contract, the performance security shall be forfeited in full and shall be credited into consolidated fund of India.
