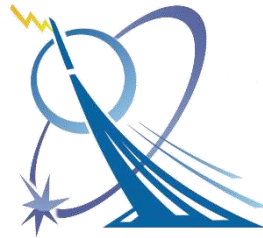

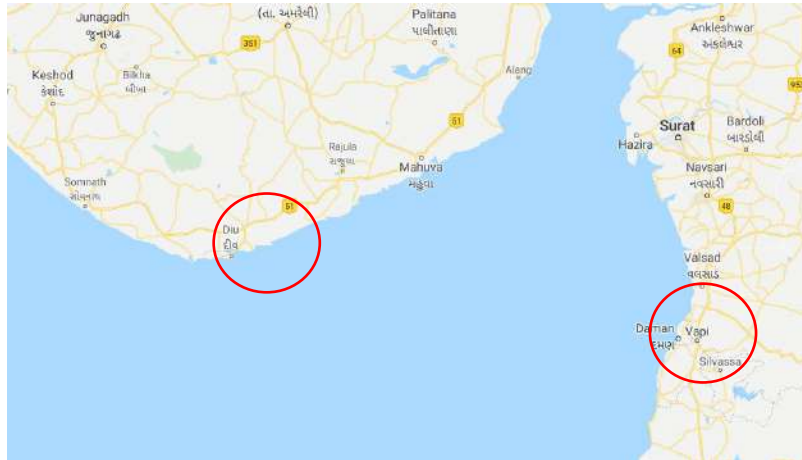

# **INTRODUCTION**

# INTRODUCTION TO ELECTRICITY DEPARTMENT OF DAMAN AND DIU

Daman and Diu are districts of Union Territories (U.T.) of Dadra and Nagar Haveli and Daman and Diu, and embedded within the State of Gujarat on the west coast of India. Administration of the Union Territory is headed by the Administrator. Electricity Department of Daman & Diu (herein after referred as ED-DD) is a part of the U.T. Administration of Dadra and Nagar Haveli and Daman and Diu. The ED-DD is headed by the Secretary (Power). ED-DD is mainly engaged in the transmission of electricity to DNHDDPDCL. The ED-DD does not own or operate any generating stations except few solar power generation plants.

As of now ED-DD own and operates rooftop and ground mounted plants at various locations in Daman and Diu. ED-DD has setup ground mounted solar PV projects 1 MWp at Magarwada, Daman and 9 (3+6) MWp in Fudam, Diu.



## Access to Site Location

Daman and Diu are physically separate territories, approximately 650 KM apart by road distance. Access to Diu by rail and road are as follows,
