The Bid Security / EMD mentioned above is to be submitted in Physical/Hard Form at the office of Superintending Engineer (RA&C), JDVVNL, Jodhpur by way of Bankers cheque/ D.D. in favour of **Jodhpur Vidyut Vitran Nigam Limited** payable at Jodhpur or Bank Guarantee (BG) in favour of Superintending Engineer (RA&C), JDVVNL, Jodhpur from any scheduled commercial bank in India, on next day of the scheduled last date & time of online bid submission. However, the scanned copy of the DD/BG is to be uploaded on bidding portal along with technical bid.
