- **Brief Description of the Bidding Process**
- **The Divisional General Manager**, on behalf of **MEDA (the Employer)**, invites eligible bidder to submit a bid in accordance with the provisions of this Tender Document. In this Tender Document, the term "Bidder", which expression shall, unless repugnant to the context, include all parties who have submitted bids in response to this Tender Document within the stipulated time frame for submission.
- The Bidders shall submit the bids in two parts by following e-tendering process described in bidding documents. First part comprises of the technical bid and the second part comprise of the financial bid in accordance with this Tender Document.
- In terms of the Tender Document, a Bidder will be required to deposit, along with its Bid, a bid security as Earnest Money Deposit (EMD).
- MEDA will open the technical bid of the Bidder, by e-tendering process. The financial bid will be open to those bidders who qualify in technical bid.
- The Bidder's Names, bid prices and the presence or absence of the requisite and such other details as MEDA, at its discretion, may consider appropriate will be announced at the time of opening.
