

Name of Work: Providing Technical Consultancy Services for Installation of Solar Power Plant

Online E-tenders are invited from the eligible registered consulting Firms having a proven experience in the establishment of the facilities in SOLAR POWER PLANT move. The detailed tender notice is as under:

1. Name of Work: Providing Technical Consultancy Services for Installation of Solar Power Plant
2. Cost of Blank Tender Form: Rs. 10,000/- + 12% GST Rs.1,200/- = Rs.11,200/- (Rupees Eleven Thousand Two Hundred Only) (Non-Refundable)
3. Class of Consultants: Consulting Firms Registered in India

All the tenders shall remain open for acceptance for 180 days from the date fixed for opening of Envelope II. i.e.; the concept with idea designs in Envelope I Technical Bid to be presented and thereafter until it is withdrawn by the Bidder by prior notice in writing.

Acceptance of the tender shall be intimated to the Bidder by email or otherwise and either by the officer competent to accept the tender or any authority in the Department including Government. Such intimation shall be deemed to be an intimation of acceptance of the tender given by the authority competent to accept the tender. In case there is difference between amount written in figures and words, the Lower offer will be taken as final.

Scope of Work

PART-1: PREPARATION OF THE DPR

Phase 1 Site visit and Assessment report

Legal verification:

The consultant shall verify the land documents provided by STBTTT or make it available on behalf of STBTTT from revenue department with the help of the legal & revenue expert. All works in relation to read & understand land plans, Revenue maps, Conversion of scales, field measurements, Site verification, Physical verification as per proposed engineering & revenue plan & to co-ordinate the work of joint measurement as per Revenue STBTTT requirement.

Site assessment:

Consultant shall carryout the site assessment in presence of STBTTT representative for the land locations available on the basis of following points.

- Solar radiation, Return of Investment and finalization of capacity of Solar Power Plant.
- Available infrastructure (approach road connectivity, water, extra bay availability)
- General profile of land
- General Topography & soil type
- Trees, Bushes, valley, hills
- Shortest possible Transmission line path and identify possible ROW (Right of Way) issue
- Capacity in MW can be installed.
- Water Tests of nearby places
- Finding shortest path for Transmission Line and ROW (Right of Way) impact, if any.
- Encroachment.

Reviewing nearby structures erected in the neighborhood so as to get preliminary idea about soil type and foundation being utilized. During this phase it is expected that the Consultant shall arrange joint visit along with STBTTT team. The arrangement for visit shall be in consultant's scope. Submitting the assessment report to STBTTT.

Phase 2 -Preparation of Bankable DPR:

Consultant will have to carry out Detailed Project Report on the land bank owned by STBTTT for PV solar projects, scope of work includes following:

Collection and generation of Commercial, Technical, Environmental and Social Assessment within the study area. This data should be relevant to decisions about project location, design,
