- «Co-gen sugar mills what pay charges of Rs. 25 per kW per month, for a period of 4 months or actual operation period, whichever is higher.
- vi. These charges shall not be applicable when the plants are under shaldown for any reason and when such shusdown period exceeds two months.
- vil. To the extent of PPA cap action of the generators with the TSD ISCOMs shall be exempted from payment of these charges.
