Inviting Comments on UPCL's proposal for determination of Additional Surcharge in accordance with the provisions of UERC (Terms and Conditions of intra-State Open Access) Regulations, 2015 to meet the fixed cost of UPCL arising out of its obligation to supply electricity to the Open Access Consumers for the period 1 April 2024 to 30

September 2024

- 1. Uttarakhand Power Corporation Limited (UPCL), the sole Distribution and Retail Supply Licensee in the State, has filed a Petition before Uttarakhand Electricity Regulatory Commission (UERC or Commission) for determination of Additional Surcharge in accordance with the provisions of UERC (Terms and Conditions of intra-State Open Access) Regulations, 2015 to meet the fixed cost of UPCL arising out of its obligation to supply electricity to the Open Access Consumers.
- 2. The computation of Additional Surcharge to be levied on Open Access Consumers, for the period 01.04.2024 to 30.09.2024 is given in the Tables below:
