Description: The rooftop solar system in question is a 1000 KWP Grid-connected Solar PV Power Plant installed on the roofs of 12 Standard Design Factories(SDFs) within Noida Special Economic Zone(NSEZ). The solar power plant is designed to generate renewable energy for the facilities and contribute to sustainable energy practices.

Key Features of the Solar Power Plant:

· Capacity: 1000 KWP

Connection Type: Grid-connected

 Location: Rooftop of 12 Standard Design Factories (SDFs) in Noida SEZ

Inverter Pannel: ABB/ WAAREE
 Inverter Capacity: 50K W & 33 K W

Scope of Work

- 1. Replacement of damaged solar modules.
- 2. Repairs of 50KW and 33KW ABB Grid Tied inverters.
- 3. Replacement of ACDB, DCDB, and associated components.
- Replacement of nut bolts, MC4 connectors, shed covers, and mounting structures.
- 5. Ensuring the optimal performance and structural integrity of the rooftop solar system.
- 6. Minimum warranty of above parts should be at least 1 years.

Major repairs:-

Several key issues were identified during the rooftop solar system assessment:

1. Damaged Modules:

• 25 solar module in the system are damaged and need replacement.

2. Inverter repairs:

- Both 50KW ABB Grid Tied and 33KW ABB Grid Tied inverters require repairs.
- Four 50KW inverters and two 33KW inverters are affected.
- · Over-temperature issues observed in the 33KW inverters.

3. ACDB Replacement:

 The AC Distribution Box (ACDB), rated IP65, requires replacement due to MCCB short circuits and the need for cable replacement.

4. DCDB Repairs/ Replacement

 Three DC Distribution Boxes(DCDB), rated IP65, require either replacement or repair

5. Nut Bolts:

 A shortage of 100 SS 304 nut bolts noted, necessitating replacement to ensure the structural integrity of the solar setup.

6. MC4 Connectors:

100 MC4 connectors are damaged and need replacement for optimal performance

7. Shed Covers:

 Seven shed covers measuring 15' X 3' are required to provide essential protection for the inverters.

10. Eligibility Criteria:-

- A. The Agencies who fulfil the following minimum eligibility requirements shall be eligible to apply.
- E. ligibility Criteria:-

Should have completed the works as mentioned below during the last seven years ending previous day of last date of submission of tenders.

 Three similar works each costing not less than 40% of the estimated cost put to tender.

The "Similar works" shall mean Supply installation of solar power plants or repairs & Maintenance of solar power plants.

- B. Average annual financial turn over shall at least Rs. 01 crores during last three (03) years ending on 31.03.2023.
- C. Must have permanent EPF& ESIC registration
- D. It should be a profit making company for last 3 years.

General Condition of Contract

 Security depost:- Security deposit shall be deducted from Bills of the contractor amounting to 3% (Three Percent) of each Bill. The Security deposit and Bid Security shall be released on successful completion of defect liability period.

<u>Defect-liability period:</u> The contractors defect liability period shall be 12 months, which will start from date of Handing over after successful completion of work. Any defect observed during DLP shall be rectified By the

contractor at his own cost.

3. <u>Payment: -</u> The contractor will submit Bill with all desired documents & test certificate with all measurements.

4. <u>Taxes:</u> -The Income tax and other taxes as applicable shall be deducted from the Bills of the contractor.

5. GST:- No GST is applicable for the work executed for NSEZ authority, Noida

- 6. <u>Time Period-</u> Work to be completed in all respect within the given time period. In case of delay, NSEZ may enforce LD amounting to 1 (one) percent of contract value for every month of delay subject to maximum of 5 % of contract value.
- 7. <u>Termination of Work:</u> If work is delayed inordinately or if contractors fails to start the work within 7 day from LOA, the client is at Liberty to terminate the work/contract. All the dues of the contractor shall be forfeited on termination. The decision of NSEZ authority shall be final & Binding on the contractor.
- 8. <u>Deviation/variation:</u> The quantities given in BOQ are tentative and may vary as per site condition. There is no any deviation limit. NSEZ authority have power to make any alterations in omission from, additions to or substitution for original specification, drawing & design and the same shall be carried out by the contractor on the same rate & condition in all respect.

 Extra Item:- Any extra item not included in the BOQ, shall be paid as per market rates. The contractor shall submit detail justification & rate analysis for

such extra items.

10. Specification of Work: The contractor to follow instruction of NSEZ authority with regard to approval of materials. The work will be executed as per specifications. Since it is a repair work of existing system, the material used shall be as per requirement and in conformity with existing system.

11. <u>Safety & Insurance:</u>- The contractor shall be responsible to follow all safety norms. All necessary safeguard will be taken. The contractor shall also obtain

suitable insurance under workmen compensation act.

12. <u>Labour laws:</u>- The contractor shall be responsible to follow all prevailing labour laws, ESIC & EPF requirements.

- 13. Temporary electric connection may be provided to contractor on chargeable basis. However, all materials, cable, meter etc to be arranged by contractor.
- 14. After completion of work, necessary testing & commissioning will be done by contractor and shall be got verified by clients before taking over.

- 16. Extension of time may be granted to the contractor, if work is delayed due to valid reasons.
