**Corrigendum dated 07/02/2024 to the Order dated 29.01.2024 in  
Petition No. 2225 of 2023.**

1. The Commission has passed Order dated 29.01.2024 in Petition No. 2225 of 2023 and decided to adopt the tariff discovered under the transparent competitive bidding process conducted by the Petitioner for Respondent No.'s 1, 3 & 4, through
