



## TAMIL NADU ELECTRICITY REGULATORY COMMISSION

Draft Notification No.TNERC/SACR/2-57 – dated 06-02-2024

### **Comments/suggestions invited by 21-02-2024**

1. The following draft of the amendment to the Tamil Nadu Electricity Regulatory Commission State Advisory Committee Regulations, 2004", which it is proposed to make in exercise of the powers conferred by section 181 read with sub-section (1) of the Electricity Act, 2003 and all other powers enabling it in this behalf, is hereby published for information of all persons likely to be affected thereby, as required by sub-section (3) of section 181 of the said Act.

2. Notice is hereby given that action will be taken to publish the proposed amendment in the Tamil Nadu Government Gazette after thirty days from the date of hosting it in the website of the Commission and that any objection or suggestion which may be received from any person with respect thereto before the expiry of the aforesaid period will be considered by the Commission.

In the said Regulations, for sub regulation (2) of regulations 12 the following regulations shall be substituted, namely:-

***"(2) A sitting fee as determined by the Commission from time to time, shall be payable to all the members of the Committee except the ex-officio member and the serving Government Employees who have been nominated to the Committee or to anyone who is otherwise found ineligible for any reason"***

## **EXPLANATORY STATEMENT**

The present amendment is proposed in "Tamil Nadu Electricity Regulatory Commission – State Advisory Committee Regulations, 2004" based on the direction given under para 2 of the Government order vide G.O.(D) No.291, Finance (Allowances) Department, dated:08.07.2020 wherein the Government has directed that honorarium should not be paid to serving Government Employees nominated to various Committees/Boards/Panels/Commissions. Further, the State Advisory Committee members have requested to increase the sitting fee from Rs.1,000/- to Rs.3,000/- stating that the honorarium of Rs.1,000/- which was fixed in the year 2004 requires revision. The proposed amendment seeks to give effect to the above decision.
