### **INTRODUCTION:**

Indian Oil Corporation Limited (IOCL), the largest commercial undertaking in India, is engaged in the business of refining, transportation and marketing the Petroleum products. IOCL, India's largest refining & marketing player is a Fortune "Global 500" company.

IOCL aims to utilize available rooftops and spare land at various locations spread all over India for installation of Solar Photo Voltaic (SPV) Plants and maximize production and utilization of Renewable Energy through these SPV Plants.

The objective of inviting applications (defined hereinafter) in accordance with this Expression of Interest Document, hereinafter referred to as EoI Document is to empanel Vendors/LSTK Contractors under different categories/regions for installation of SPV Plants at various locations spread all over India, as per the requirements.

Start-up/MSE to submit details of sales/service setup against item 1.15 of Annexure-2. Self-attested copies of a registration certificate of establishment (sales/service office) from a Government agency or local GSTIN Registration must be submitted along with application as documentary evidence.

7. "Criteria for existing"Empanelled Vendors/LSTK Contractors for Solar PV Plants at IndianOil Locations and Retail Outlets":

Applicant (Individual/Partnership) / Applicant Company who are already empanelled with Indian Oil as "Vendors/LSTK Contractors for Solar PV Plants at IndianOil Locations and Retail Outlets" under respective Category/Region:

a) Must have participated in at least one limited tenders for Solar PV Plant under respective Category/Region at IndianOil Locations in which they are empanelled in which their firm/Company was invited to bid during 1st August 2022 to 31st January 2024

  - ii. MSE to submit valid MSE certificate registered under MSME Act 2006.
  - iii. One Director/Partner/Proprietor should have minimum three years of experience related to work experience mentioned in Eligibility Criteria of EoI document and his/her base date of Directorship/Partnership/Proprietorship shall be before the date of this EoI. Credentials (CV/Resume) of Director/Partner/Proprietor are required to be submitted to assess the quality, commitment and technical capabilities of the Startup/MSE Company to qualify for this EoI.

iv. Nature of the business as mentioned in Start-up certificate must be related to solar power plant installation services.
