1.0 INTRODUCTION

- 1.1 Chennai Petroleum Corporation Limited (CPCL) (formerly known as Madras Refineries Limited) is a Public Sector Enterprise and a group company of Indian Oil Corporation Limited (IOCL) with 10.5 MMTPA Refinery at Chennai, Manali and 1 MMTPA Cauvery Basin Refinery (CBR) at Nagapattinam, Tamilnadu.
- 1.2 A 9 MMTPA Cauvery Basin Refinery & petrochemical (CBRPL) Project is ongoing at Nagapattinam, Tamilnadu.
- 1.3 As a part of this project, 4.5 MWp grid interactive Ground Mounted Solar Power plant that has been installed in Muttam, Nagapattinam, Tamilnadu is to be dismantled and reinstated in new location of Project site.

2.0 BACKGROUND

- 2.1 This 4.5 MWp grid interactive Ground Mounted Solar Power plant was commissioned in the year 2016 and is under working condition.
- 2.2 Details of the installed plant facility are as under :

3.0 PRE-QUALIFICATION CRITERIA

- 3.1 Bidders should have experience of either of given below two qualifications:
 - a) "Installation, Testing, Commissioning and O & M of minimum 2 MWp Solar Plant" executed by the bidder as main contractor or sub-contractor during any of the last 10 (Ten) years ending on last day of the month immediately previous to the month in which last date of bid submission falls.
 - b) "Installation, Testing and Commissioning of minimum 2 MWp Solar Plant" executed by the bidder as main contractor or sub-contractor during any of the last 10 (Ten) years ending on last day of the month immediately previous to the month in which last date of bid submission falls.

4.0 SCOPE OF BIDDERS

- 4.1 Providing layout for the new Solar Plant for 4.5 MWp Capacity in the available 16 acres land including solar Panels, maintenance access-ways, roads, drains, electrical equipment such as SCADA, UPS, Inverters, PLC, switchboard, etc.
- 4.2 Providing design and detailed construction drawing for Module Mounting Structure (MMS) and RCC foundation, control room, substation/inverter room, guard cabin, transformer foundation, transformer shed, roads and drains, cleaning system comprising of pumps and storage tanks, etc.
- 4.3 Dismantling of the PV Modules along with their support structures {except Mounting module structure (MMS) verticals}, electrical accessories such as 32 Nos String Monitoring boxes, Weather monitoring stations, 4 Nos. inverters, 4 Nos. transformers, Scada System, PLC panel, 30 Batteries and UPS (01 No 20KVA), approx. 72 Nos. Solar Street lamps, 02 Nos. Water Pumps and booster pumps, water tank with PVC Piping (used for washing of solar panels) from the existing location.
- 4.4 Shifting of all dismantled items safely from the dismantled area, transportation and erection of same at new location.
- 4.5 Maximum of dismantled structural material along with PV Modules and other electrical items shall be reused.
- 4.6 Installation and commissioning of solar plant in new location.
- 4.7 Dismantling, shifting and installation of solar plant shall be carried out in multiples of 1 MW (AC).
- 4.8 Design, engineering, supply, erection, commissioning of fire water protection and/or detection and/or prevention system as per statutory authority's guidelines/recommendations.
- 4.9 Mobilization, hiring, demobilization of all types of heavy equipment like hydra, crane, tractor and trolley (irrespective of size, rating, capacity, type), etc., all types of manpower, general and special lifting tools & tackles.
- 4.10 Supply of scaffolding material, erection and dismantling of scaffolding as necessary.
- 4.11 All statutory compliances and approvals related to CEIG (TNEB), MNRE, CEA, etc.
- 4.12 All statutory requirements related to Safety and Firefighting, etc. to be complied.



4.13 Comprehensive Operation & Maintenance of shifted 4.5MWp solar plant for 03 years after installation.

5.0 SCOPE OF CPCL

- 5.1 Soil filled, graded and compacted land upto the Finished Ground level required for setting-up of the Solar Plant system.
- 5.2 All civil construction works for the new plant including roads, drains, all civil foundations, buildings, substation, transformer sheds inverter room, control room, security guard cabin, foundations for module mounted structure lighting poles, double pole structure, pumps & water tank and any other civil work associated with the new solar plant.
- 5.3 Fencing of the entire plant.
- 5.4 Subject to availability, construction power may be provided as a single source to the existing site on chargeable basis and contractor to make their further arrangement for distribution of same.
