## 1. ELIGIBILITY CONDITIONS:

- 1. The minimum average annual Turn Over of bidder, during last 3 Financial Years (2021-22, 2022-23 & 2023-24), should be Rs. 26.13 Lacs & should have positive net worth. Balance sheets & requisite CA certificate be provided.
- 2. The bidders should have experience of successfully completed Similar\* works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
  - a) Three similar completed works costing not less than the amount equal to Rs. 34.84 Lakhs.
  - b) Two similar completed works costing not less than the amount equal to Rs. 43.56 Lakhs.
  - c) One similar completed works costing not less than the amount equal to Rs. 69.69 Lakhs.
- \* Supply of Structures for Solar PV projects / Supply of Solar Motor Pump sets / installation of Solar Based Community Drinking Water System in villages in rural areas for community drinking water under any PSU/Govt. Projects. Requisite documentary evidence from PSU / Govt Dpt in form of completion certificate be provided.

#### 2. OTHER CONDITIONS:

I.

- A) **Responsibility for executing Contract**: The Bidder is to be entirely responsible for the execution of the contract in all respects in accordance with the terms and conditions as specified in the acceptance of bid.
- B) The Bidder shall not sublet transfer or assign the contract or any part thereof without the written permission of the AGM (MM-BOS). In the event of the Bidder contravening this condition, AGM (MM-BOS) be entitled to place the contract elsewhere on the Bidder's account at his risk & cost and the Bidder shall be liable for any loss or damage, which the AGM (MM-BOS), may sustain in consequence or arising out of such replacing of the contract.

C) <u>Document</u>: The Bidder should have a valid **PAN** / **GSTIN** Other statutory document as applicable and produce attested copies of such certificates along with the bid papers in Technical Bid, failing which the bid is liable to be rejected.

#### C) Right to accept/ reject:

REIL reserves the right to **reject** any or all bid without assigning any reason whatsoever. Also, the REIL authority reserves the right to **award** any or part or full contract to any successful agency at its discretion and this will be binding on the Bidders.

- D) The allocations capacity of the SPV water pump can be increased or decreased to any extent.
- E) REIL reserves the right to distribute the work among the eligible Bidder on L1 Rate depending on their financial capability, experience, field maintenance strength, availability of bidders, market scenario/feedback, business opportunities, and availability of infrastructure/service center, Exposure in specific area etc. L-1 party be given more opportunity if interested.
- F) REIL is right to reject/cancelled the allotted work to any vendor, if progress is not Satisfactory. In this case the work may be allotted to other vender on their risk and cost.

#### **SCOPE OF WORK**

Scope of work# covers Design, Providing BOS, Installation & Commissioning of 2 HP Solar Energy Based Bore Well Water Pumping System including O& M period for 7 Year for Community Drinking Water in the State of Rajasthan conforming to technical specification of tender documents.

# Note: Solar Photovoltaic modules shall be provided by REIL

- (A) Detailed scope of work is given here under:-
- 1. **DESIGN & SUPPLY OF MS FABRICATED STRUCTURE:** Work includes designing of solar panel area and supply of MS fabricated structure 120 micron hot dip galvanized iron, showing arrangement of panel in available space and installation of PV module on frame structure to safeguard against damage and theft as per indicative drawing provided.
- 2. **FOUNDATION OF STRUCTURE:** The foundation of structure shall be in RCC. Mounting structure shall be suitably designed to withstand wind velocity up to 150km/hr. The work shall be executed as per **detailed technical specifications(s)**, approved drawing and direction of Engineering Charge.

**Note:** There shall be 7 year service warranty for mounting structure and suitable provision to be included.

- 3. AC/DC SUBMERSIBLE PUMP SETS: Providing, installation, testing and commissioning of sets (suitable for 90 to 120 mtrs head) AC/DC submersible pump (capacity 2 HP, for providing minimum 10000 lts water per day in a lean month of December) with inbuilt or individual solar pump controller with Maximum power point tracking (MPPT) for optimally use the solar panel and maximize water discharge to deliver maximum water during the day. Including PVC flat submersible cable from controller to motor pump. Solar pump shall be of Stainless steel construction and performance shall be as per scope of work and minimum lift of water shall be as per defined in scope. Pump controller shall have adequate protection against dry operation of motor pump set, and against hails and storms. Full protection against open circuit, accidental short circuit and reverse polarity should be provided. A good reliable on/off switch be provided. The cable shall be ISI marked three core PVC flat submersible cables as per IS 694:1990 or amended up to date (standard insulation) and conductor as per class 5 of IS 8130:1980 or amended up to date. The duty condition of pump set shall be as per scope of work and entire work shall be executed as per technical specification and direction of Engineer in charge.
- 4. **REMOTE MONITORING UNIT:** Supply, installation, testing and commissioning of remote monitoring unit on solar controller for remote ON/OFF, parameter setting, monitoring and troubleshooting through mobile etc. complete. Web charges and data charges for 1 year during service warranty etc. complete in all respect **as per technical specification(s)** and as per direction of Engineer.

#### 5. INSTALLATION, TESTING AND COMMISSIONING STRUCTURAL STEEL WORK:

Providing, installation, testing and commissioning structural steel work riveted or bolted in built up sections, trusses and framed work, including cutting, hoisting for following staging and capacity of Rotational Moulded Polyethylene water storage tank on it as per indicative drawing. On the Polyethylene tanks, there shall be provision of suitable space for installation of solar panels as per indicative drawing. The structural steel shall be 120 micron hot dip galvanized iron and foundation of structure shall be in RCC with minimum depth as 1.5 mtr (other than rocky strata). The work includes P&F of Polyethylene Water Storage Tank (IS: 12701, ISI marked, indicating the BIS license No.) of approved make with cover. Providing & fixing 50 mm dia ISI marked G.I. class B pipe for inlet, outlet and over flow pipe and 32 mm GI class B pipe for wash out with GM gate valves at inlet and outlet pipe Including making connection etc. complete as per drawing, technical specification(s) and direction of Engineer in charge. The scope includes inlet GI pipe from ground level to water tank and outlet pipe from water tank to ground and up to 2.0 mtr away from foundation and overflow pipe is to be interconnected in distribution pipe line. Wash out pipe shall be taken up to a suitable point minimum 5.0 mtr away from tank. Water level controller shall installed to monitor level in tank and shall automatically shut off motor when tank is filled 5000 ltrs X 1 nos. PE water Tank staging 3 mtrs.

- 6. Operation & maintenance of solar system for 7 years.
- 7. Any other work required to make the system operational.
- 8. Indicative drawing attached in the bid document.
- 9. Bidder to ensure water yield in bore well. In case of failure of bore well, the system would be reinstalled at the new location where bore well is available.
- 10. System should be insured for a period of 7 year again theft, damage, bore well collapse or any other unforeseen event.
- 11. Bidder shall ensure development of web portal for RMS data. In case the same is to be reflected on some other portal bidder shall ensure the RMS data reflection shall be as per requirement of REIL

#### (B) TRANSPORTATION, DEMURRAGE, WHARFAGE, ETC.:

Transportation & delivery of SPV System from centralized location to installation site shall be arranged by the Contractor, and the related cost shall be included in the Contract Price.

The bidder should not have been black-listed by any Central / State Government or Public Sector Undertakings. If at any stage of tendering Mess or during the currency of the contract, any suppression / Falsification of such information is brought to the knowledge, REIL shall have the right to reject the proposal or terminate the contract, as the case may be, without any compensation to the tenderer.

#### (C) OTHER TERMS & CONDITIONS:

- a. Bidder shall create go-down in Districts for safe storage of material for proper security arrangement if required.
- b. Transportation & delivery of SPV System from centralized location to installation site and submit the duly verified receipt. Storage, Safety and security of the material till the system is handed over to user, shall be the responsibility of bidder if required.

- c. The system should be properly installed at site as per drawings provided by REIL. Any minor items which are not specifically included in the scope of supply but would be required for proper installation and efficient operation of the SPV systems, is to be provided by the bidder as per standards.
- d. Verification of document such as installation certificate, bills etc. from the concerned department.
- e. Company official/ customers reserve the right to visit and inspect any site at any time. Improvement / suggestions in workmanship and quality shall be immediately adhered. All logistic support for verification/ inspection work shall be provided by the bidder.
- f. Bidder shall be fully responsible for all repairs of the defects in installation and commissioning if found during the period under contract.
- g. Photograph of Installed system along with beneficiary & GPS location shall be provided in soft as well as hard copy by Bidder & shall also be uploaded on website if required.
- h. Bidder shall provide training to beneficiary regarding operation and maintenance of SPV System.
- i. Bidder shall establish main service center to provide repairing assistance.
- j. Submission of installation document (Data Entry) in hard & Soft Copy provided by the bidder.

#### 4. OPERATION & MAINTENANCE:

Following shall be the scope of work during warranty of 7 year –

- 1. Repairing/Replacement against fault of Solar Pump, Controller, Remote Monitoring system, as and when required during the warranty period of 7 year.
- 2. Payment for GPRS SIM for remote monitoring system during the warranty period of 7 year.
- 3. Basic training to be given to the concerned person(s) nominated by Sarpanch/customer for Operation & Maintenance.
- 4. Bidder shall maintain the system for 7 year from the date of Installation of System.

#### GENERAL TERMS & CONDITIONS OF THE CONTRACT

#### 1) AMENDMENT

Except as otherwise provided herein, no addition, amendment to or modification of the Contract shall be effective unless it is in writing and signed by and on behalf of both parties.

#### 2) **SEVERABREILITY**

In the event that any or any part of the terms conditions or provisions contained in the Contract shall be determined invalid, unlawful or unenforceable to any extent such term, condition or provision shall be served from the remaining terms, conditions and provisions that shall continue to be valid and enforceable to the fullest extent permitted by law.

#### 3) CONFIDENTIAL TREATMENT

It is understood and agreed that data, know-how and other such proprietary information that was provided or will be provided by either party, will remain confidential.

#### 4) **RELATIONSHIP OF THE PARTIES**

REIL relationship with Bidder will be that of a Business Associate, and nothing in this Contract shall be construed to create a relationship, joint venture, partnership.

#### 5) **INDEMNITY**

REIL and the Bidder will indemnify, defend, and hold harmless each other and its divisions, successors, subsidiaries and affiliates, the assigned of each and their directors, officers, agents and employees from and against all liabilities, claims, losses, and damages of any nature, including, without limitation, all expenses (including attorney's fees), cost, and judgments incident there to REIL and REIL's obligations under this indemnity will survive the expiration, termination, completion or cancellation of this Contract or an order hereunder.

#### 6) RESTRICTIN ON EMPLOYMENT

Both the parties have agreed that they will not recruit any members of staff of other party directly or indirectly.

#### 7) **ARBITRATION**

The parties agree to use their best efforts to resolve any dispute that may arise under the Agreement through good faith negotiations. No party shall commence any litigation in relation to this Agreement unless it has first invited the Chief Executive of the other party (or any person duly authorized to action his behalf) to meet with its own Chief Executive (or any person duly authorized to act on his behalf) for the purpose of endeavoring to resolve the dispute on mutually acceptable terms. Any dispute arising under this Agreement which cannot be settled by negotiation / mediation between the parties, or their respective representatives shall be submitted to the competent court of law. The courts situated at Jaipur only shall have the jurisdiction.

#### 8) RISK AND COST

In the event of failure on the part of the Bidder in the supply, installation and commissioning of goods and services, which is required in view of the pending orders, REIL shall be entitled to cancel the remaining order and procure the outstanding quantity through other sources at risk and costs of the Bidder.

#### 9) TERMINATION OF CONTRACT:

REIL shall be entitled to terminate this Contract, in the event of any or all or any of the following events, with a written notice of 15 days with due consent of the Bidder:-

- i. has abandoned the Contract
- ii. has without valid reason failed to complete the projects in respect of the contract.
- iii. persistently fails to execute the Contract in accordance with the Contract or persistently neglects to carry out its obligations under the Contract without just and proper cause.

#### 10) DURATION OF CONTRACT

This contract shall take effect on the day of execution of this contract and shall endure for the period of 1 year from date of commissioning and hand over the Power Plant(s) to beneficiary and renewable as per mutual agreement.

#### 11) **GOVERNING LAW**

This contract and its validity, interpretation and performance will take effect and be governed under the laws of India. Venue in any action in law or equity arising from the terms and conditions of this contract shall be the court of appropriate jurisdiction in Jaipur, Rajasthan (India)

#### 12) PREFERENCE TO MSME

Preference to MSE will be given and procurement from SC/ST and Women Entrepreneurs shall be done as per the government guidelines. Start Ups are exempted from condition of prior turnover and prior experience subject to meeting of quality and technical specifications "as per Eligibility Conditions (Annexure-II)."

#### 13) **CONTRACT:**

Before execution of the work, security deposit (5% of contract value) be submitted and a contract agreement for execution of the work shall be signed by the Bidder with REIL within 7 days of LOI from REIL. In case agreement is not executed within the stipulated time, earnest money will be forfeited.

#### 14) PAYMENT & OTHERS TERMS

#### **PAYMENT:**

- a) 65% payment or on pro-rata basis will be released after supply of material at site & successfully Installation & commissioning of system, submission of Installation & Commissioning certificate dully signed by Customer/Beneficiary (as per perform at annexure XI) along with photographs of the installation site and verify by the REIL Engineer/ in-charge and after receipt of REIL payment from end customer.
- b) 5 % payment or on pro-rata basis will be released after successful maintenance and verify by the REIL Engineer/PHED in-charge and after receipt of REIL payment from end customer.

#### **Project completion period:**

60 days of LOI/ work order

#### **Agreement:**

Successful bidder shall submit the agreement on non judicial stamp paper of Rs. 500/- within 7 days from the date of award of Contract.

#### LD:

Back to back LD shall be imposed on party, if any on REIL from end customer towards delay in execution of contract.

#### 15) **FORCE MAJEURE:**

i.Notwithstanding the provisions contained in the Bidding Documents; the Bidder shall not be liable to forfeit (a) Bid Security for delay and (b) termination of contract; if it is unable to fulfill its obligation under this Contract due to force majeure conditions.

For purpose of this clause, "Force majeure" means an event beyond the control of the Bidder and not involving the Bidder's fault or negligence and not foreseeable, either in its sovereign or contractual capacity. Such events may include but are not limited to Acts of God, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes etc. Whether a "Force majeure" situation exists or not, shall be decided by REIL and its decision shall be final and binding on the Bidder. REIL may extend the date of completion for a further period corresponding to the period of force majeure.

ii.If a force majeure situation arises, the Bidder shall notify REIL in writing promptly, not later than 7 (seven) days from the date such situation arises. The Bidder shall notify REIL not later than 3 days of cessation of force majeure conditions. After examining the cases, REIL shall decide and grant suitable additional time for the completion of the work, if required.

#### 16) OTHER TERMS & CONDITIONS:

- i Compliance with Regulations and Indian Standard:- All works shall be carried out in accordance with relevant regulations, both statutory & those specified by the Indian standard related to the works covered by this specification. In particular the equipment and installation will comply with the following:
  - a. Work man's compensation act.
  - b. Minimum wages Act.
  - c. Payment wages Act.
  - d. Contact Labour regulation & abolition Act.
  - e. ESI, PF & Bonus Act.
  - f. Regulation under Indian Electricity Rules,
  - g. Safety & electrical Standard as applicable

#### ii Watch & Ward:-

The Bidder shall supply material (including REIL SPV Modules) from his godown for installation work at site, shall continue to be responsible for their safe custody till they are installed in position, tested, commissioned and handed over to beneficiaries as per format provided by REIL if required.

iii Bidder shall arrange for compliance with statutory provision of safety regulation and departmental requirements of safety codes in respect of labour employed on the work by the Bidder. Failure to provide such safety requirements would make the Bidder liable for penalty. The department will

- make arrangement for the safety requirements at the cost of the Bidder & recover the cost thereof from him.
- iv Company shall not be held liable or responsible for any illness and for physical harm sustained by the Bidder authorized representative during the execution of this agreement as they will not be deemed in any manner as employee of the company.
- The Bidder authorized representative shall take due care in handling the SPV system under this contract. Unwarranted activities, if found any, the company shall be authorized to recover the same from the Bidder.
- vi Correction, over-writing and alteration should be initialed and dated by the Bidder otherwise the bid is liable to be rejected. The bid shall be typed or written in ink. Unit rates should be mentioned in the specified format failing which the bids are not likely to be considered.
- vii All Bidders shall therefore, furnish declaration that their firm is not involved in any litigation that may have an impact of affecting or compromising the delivery if services as required under this assignment. It is also to be declared that their firm has not been black listed by any Central/State/Public Sector Under takings in India. The declaration should be verified by the Notary Public.
