DAILY ORDER

- 1. The matter was kept for hearing on 17.09.2024.
- 2. Ld. Adv. Mr. Pratyush Singh appearing on behalf of the Applicants/Petitioners submitted that the Applicants/Petitioners are developing Wind Power Projects in the State of Gujarat for supply of entire installed capacity to Respondent No. 2 GUVNL as selected under the Competitive Bidding Process conducted by GUVNL. The Applicants/Petitioners are aggrieved by the arbitrary and unjust cancellation of Stage-II connectivity applications for aforesaid wind projects at 400 KV Bhogat Sub-station by the Respondent No. 1 GETCO and therefore have preferred the present Petition.
- 2.1. He also submitted that Applicants/Petitioners have received copy of reply from the Respondent GETCO and the Respondent GUVNL is yet to file its reply in the matter. He requested the Commission to direct the Respondent GUVNL to file its reply, if any, in the matter to enable the Applicants/Petitioners to file rejoinder reply in the matter. It is further requested that the Commission while granting adjournment may grant week' time to the Applicants/Petitioners to file rejoinder reply in the matter.
 - 3. Ld. Adv. Ms. Shrishti Khindaria, appearing on behalf of the Respondents GETCO and GUVNL submitted that the Respondent GETCO has filed its reply on 17.08.2024 in the matter and also served upon the copy of the same to the Applicants/Petitioners. She also requested the Commission to grant some time to file a reply on behalf of the Respondent GUVNL in the matter. As such, there is no objection to the adjournment sought by the Applicants/Petitioners.
 - 4. Considering the request of the Applicants/Petitioners to adjourn the matter and there is no objection to the same by the Respondents, the matter stands adjourned. We note that the Respondent No.1 GETCO has filed its reply on

17.08.2024 in the matter and also served the copy of the same to the Applicants/Petitioners. We also note that the Respondent No. 2 GUVNL has not filed its reply in the matter. Accordingly, let the reply, if any, be filed by the Respondent GUVNL, within two weeks' time with a copy to the Applicants/Petitioners. The Applicants/Petitioners are also at liberty to file their rejoinder reply, if any, within two weeks' time with a copy to the Respondents.

- 4.1. We also note that the Applicants/Petitioners have filed IA in the Petition No. 2373 of 2024 being IA No. 24 of 2024 in Petition No. 2373 of 2024 before this Commission. Since, IA No. 24 of 2024 in Petition No. 2373 of 2024 is filed for seeking urgent listing and the Commission having taken up the main matter for hearing, the prayer in I.A. No. 24 of 2024 filed for seeking urgent listing of main matter has served its purpose. Accordingly, IA No. 24 of 2024 in Petition No. 2373 of 2024 stands disposed of.
 - 5. Next date of hearing will be intimated separately.
 - 6. Order accordingly.
