**ORDER**  
**(DATE OF HEARING: 01.04.2025)**

1. The Commission, vide its earlier Order dated 18.03.2025, had allowed two weeks' time to Respondents to file their reply and one weeks' time to Petitioners to file their rejoinder thereafter. The Commission had also directed UPNEDA to furnish 'Bid Conformity Certificate'. On 26.03.2025, Respondent No. 9 & 10 filed their reply. On 28.03.2025, Respondent No. 1 & 8 filed their reply and UPNEDA filed its 'Bid Conformity Certificate'.
2. During the hearing on 01.04.2025, Sh. Himanshu Singh, Advocate of Respondent No. 12 sought one week time to file its reply in the matter. Sh. Divyanshu Bhatt, Counsel of Petitioner(s) pleaded for reserving the Order in the matter as the Commission had already allowed sufficient time to Respondents to file their reply. On specific query of the Commission about status of the remaining replies, Sh. Bhatt responded that remaining Respondents had served their applications through emails on the previous day wherein a week time was sought for filing Written Submissions. Further, in response to the Commission's query, Sh. Himanshu Singh submitted that he was also representing Respondent No. 2, 3, 4, 5, 6, 7 & 12 in the matter.
3. The Commission expressed its anguish that few Respondents were wilfully delaying filing of their reply, which is testing the patience of the Commission. Further, the Commission noted that Respondent No. 11 though present in the previous hearing dated 11.03.2025, had neither filed its reply nor was present in the present hearing



without any information to the Commission. Sh. Bhatt submitted that issues raised in the replies, filed by Respondents, were on similar grounds.

4. After hearing the parties, the Commission allowed one weeks' time to the remaining Respondents barring Respondent No. 11 due to his unbecoming approach as stated in the previous paragraph of this Order. Further, UPNEDA was allowed to file its rejoinder to the Respondent's replies submitted till date.
