Record of Proceedings

The representative of the Petitioner submitted that the present Petitions have been filed for the grant of a transmission licence for implementing an inter-State transmission project, viz. "Transmission System for supply of power to Green Hydrogen/Ammonia Manufacturing potential in Mudra area of Gujarat under Phase I: Part B1 Scheme (3 GW at Navinal S/s)" ('the Project') and the adoption of transmission charges through the tariff based competitive bidding process for the said Project.

2. After hearing the representative of the Petitioner, the Commission directed as under:

- (a) The Petitioner to implead POWERGRID (for Bhuj PS) and Adani Energy Solutions Ltd., the TSP of Navinal (for the Mundra S/s), as parties to the petitions
