Petition filed under Section 86 (1) (b) of the Electricity Act, 2003 read with the HERC (Conduct of Business) Regulations, 2019 seeking source approval and PPA approval for procurement 340 MW power from (1) Dibang Multipurpose Project (167 MW); (2) Teesta VI HEP (30 MW); (3) Rangti IV HEP (11 MW); (4) Ratle HEP (21 MW) (5) Pakal Dul HEP (39 MW), (6) Kwar HEP (35 MW) and (7) Kiru HEP (37 MW), hydroelectric projects from subsidiaries of NHPC Ltd., as allocated by the Ministry of Power vide its letters dated 25.02.2025 and 15.04.2025, at the tariff to be determined under Section 62 of the Electricity Act, 2003 by the CERC.

The present petition has been filed by the Petitioner, HPPC Section 86 (1) (b) of the Electricity Act, 2003 read with the HERC (Conduct of Business) Regulations, 2019 seeking source and approval of the Power Purchase Agreement (PPA) the following hydroelectric projects of NHPC Ltd. and its subsidiaries for procurement 340 MW power from:
 - (1) Dibang Multipurpose Project (167 MW)
 - (2) Teesta VI HEP (30 MW)
 - (3) Rangti IV HEP (11 MW)
 - (4) Ratle HEP (21 MW)
 - (5) Pakal Dul HEP (39 MW)
 - (6) Kwar HEP (35 MW) and
 - (7) Kiru HEP (37 MW)

As allocated by the Ministry of Power vide its letters dated 25.02.2025 and 15.04.2025, at the tariff to be determined under Section 62 of the Electricity Act, 2003 by the Central Electricity Regulatory Commission(CERC). Accordingly, the petition is **admitted** for consideration.
