## **Record of Proceedings**

At the outset, the learned counsel for the Petitioner submitted that the Petitioner has already applied for the connectivity for its 2182 MW of Solar Plant on Land + Bank Guarantee route [i.e., Regulation 5.8(xi)(c)] and is now only urging the Commission to relax (i) the timeline for the submission of 50% land documents under Regulation 5.8(xi)(c) read with Regulation 11A of the GNA Regulations to 30 months from the date of in-principle grant of connectivity by CTUIL, and (ii) the requirement of submission of Bank Guarantee under Regulation 5.8(xi)(c) of the GNA Regulations to 2 lakhs/MW. Learned counsel submitted that the Petitioner has already filed its affidavit to the above effect, which may be considered by the Commission, and the matter may, accordingly, be reserved for the order.

2. Learned counsel for the Respondent, CTUIL, submitted that the Petitioner's above affidavit has been received only yesterday night and CTUIL may, therefore, be permitted to examine the same and furnish its comments, if required.

- Considering the submissions made by the parties, the Commission directed 3. the Petitioner to upload its above affidavit on the e-filing portal within a week and CTUIL to file its comments thereon, if any, within a week thereafter.
- 4. Subject to the above, the matter was reserved for order.
