# Record of Proceedings (on remand from APTEL)

During the hearing, the learned counsel for the Petitioner submitted that it has filed the written submissions in terms of the directions of the Commission. However, the learned counsels appearing for some of the Respondents present, sought time to file their written submissions in the matter. Accordingly, the hearing was adjourned.

- 2. The Petitioner is directed to file the following additional information on affidavit, after serving a copy to the Respondents, on or before **13.6.2025**:
  - (a) Recommendations of OEM Boiler manufacturer and Turbine manufacturer or any of the RLA studies carried out, clearly stating the quality of the equipments and further period of extended life w.e.f. the completion of the useful life of the generating station, along with the reason for extension of its useful life.
  - (b) **Details of the Special allowance:** The details of the Special allowance that are maintained separately from the completion of useful life of each generating unit/station (w.e.f. unit wise completion of useful life) till 31.3.2024.



- (c) The unit wise/station wise details of the schemes/expenditure and each asset that are funded through special allowance in the format attached as Annexure-A, duly certified by an Auditor.
- (d) The unit-wise/station-wise details of the special allowance allowed, completed/approved cost of R&M schemes of respective units/stations with details of year-wise expenditure incurred/projected to be incurred in the format attached as Annexure-B, duly certified by the Auditor.
- (e) Certify that the expenditure as detailed in the formats under Annexure-A and Annexure-B enclosed has not been met/claimed out of O&M expenses and additional capital expenditure.
- (f) Justification for the additional capital expenditure claimed under Regulation 14(3), along with supporting documents.
- (g) Justification for claiming deferred work towards ash pond and ash-related works, after completion of the useful life of the generating station.
- (h) The estimated expenditure envisaged for Ash related works and ash pond activities undertaken as per investment approval, along with the actual expenditure incurred compared to the approved amount in the investment approval from the date of Investment approval to the COD of the units/ generating station and from COD to the completion of useful life.
- 3. The Respondents are permitted to file their written submissions in the matter, if not filed earlier, on or before **26.6.2025**, after serving a copy to the Petitioner, who may file their response, if any, by **3.7.2025**.
- 4. These Petitions will be listed for hearing on **8.7.2025**.
