## Record of Proceedings

The instant Petition has been filed by the Petitioner for the truing-up of the transmission tariff for the 2019-24 tariff period and for determination of tariff for the 2024-29 tariff period, in compliance with the Commission's order dated 14.3.2012 in Petition No. 15/Suo-Motu/2012, in respect of natural inter-State transmission lines, namely, 400 kV Bawana–Mandaula Double Circuit transmission line (Asset-1) and 400 kV Bamnauli–Ballabhgarh Double Circuit transmission line (Asset-2).

2. During the hearing, the representative of the Petitioner submitted that the Commission, in its order dated 29.6.2018 in Petition No. 175/TT/2017, had substantially reduced the capital cost relating to the transmission lines while determining the tariff for the 2014-19 tariff period, based on the methodology laid down by the Commission in its common order dated 19.12.2017 in Petition Nos. 88/TT/2017,173/TT/2016, and 168/TT/2016, despite the Petitioner having provided



complete details and information as required by the 2014 Tariff Regulations. He further submitted that aggrieved by the order dated 29.6.2018, the Petitioner filed Review Petition No. 40/RP/2018, which was dismissed by the Commission in its order dated 29.11.2019. Subsequently, the Petitioner filed Appeal No. 223/2022 before the Appellate Tribunal for Electricity (APTEL) against the Commission's order dated 29.6.2018 in Petition No. 175/TT/2017, which is pending adjudication.

- 3. After hearing the Petitioner's representative, the Commission directed the Petitioner to submit, on an affidavit, within two weeks, the current status of the appeal pending before the APTEL, along with records of all hearings held in the matter till date.
- 4. The Commission further directed that notice be issued to the Respondents, who shall file their respective replies, if any, within four weeks with a copy to the Petitioner, who may file its rejoinder, if any, within two weeks thereafter.
- 5. The Petition will be listed for further hearing on **20.8.2025**.
