Record of Proceedings

The representative of the Petitioner submitted that the present Petitions have been filed for the adoption of transmission charges for the Inter-State Transmission System, viz. "*Transmission Scheme for integration of Davanagere / Chitradurga REZ and Bellary REZ in Karnataka*" (hereinafter referred to as "the Project"), as discovered pursuant to the tariff-based competitive bidding process, and for the grant of a transmission licence for establishing the Project. He further submitted that the Petitioner has complied with all the requirements specified in the Transmission Licence Regulations, 2020 and also the recommendation of CTUIL under Section 15(4) of the Electricity Act, 2003 has been placed on record. He added that there had been a delay of six days in filing of the present Petitions, which occurred due to

the non-reflection of the Petition filing fees on the e-filing portal. He, accordingly, also requested that the said delay be condoned.

2. Considering the submissions made by the representative for the Petitioner, the Commission directed as under:

- a) The Petitioner to implead Khandwa Power Transmission Limited (Sterlite Grid 4 Limited), as party to the present Petitions and file a revised memo of parties within two days.
- b) Admit and issue notice to all the Respondents, including the impleaded Respondents.
- c) The Respondents, to file their respective replies, if any, within a week with a copy to the Petitioner, who may file its rejoinder(s) within a week thereafter.
- d) CTUIL is directed to submit the following information on an affidavit within a week:
