### **Record of Proceedings**

The representative of the Petitioner submitted that the present Petitions have been filed for truing up of the transmission tariff for the 2019-24 tariff period and determination of the transmission tariff for the 2024-29 tariff period. The representatives of the Petitioner requested that the transmission tariff be allowed as claimed in the respective Petitions.

2. Learned counsel for the Respondent, BSES Rajdhani Power Limited (BRPL) & BSES Yamuna Power Limited (BYPL), sought two weeks' time to file replies in Petition Nos. 201/TT/2025, 202/TT/2025, and 363/TT/2025.

3. Learned counsel for the Respondent, Uttar Pradesh Power Corporation Limited (UPPCL) (Appearance not conveyed), sought two weeks' time to file its replies in Petition Nos. 363/TT/2025 and 376/TT/2025.

4. After hearing the representative of the Petitioner, and learned counsels for the parties, the Commission directed the Respondents, including UPPCL and BRPL & BYPL, to file their respective replies, if any, on an affidavit within two weeks', with a copy to the Petitioner, who may file its rejoinder within a week thereafter.

5. The Commission further directed the Petitioner to submit on an affidavit the Form-5 within a week in Petition Nos. 201/TT/2025, 202/TT/2025 and 363/TT/2025 for all assets.

6. The above Petitions will be listed for further hearing on **22.7.2025**.
