DAILY ORDER

1. The present matter was listed for hearing on 09.06.2025.
2. When the matter was called out, nobody was present on behalf of the Petitioner. We note that the Petitioner neither remained present during today's proceedings nor made any written communication about their inability to remain present, despite being served the hearing notice to them.
3. We note that during the last hearing on 29.05.2025, the Petitioner was not present and sent an email dated 29.05.2025 stating that due to short notice the Petitioner is not able to remain present as they require time for necessary preparation and accordingly requested that the hearing in the matter may be postponed to other convenient date. However, as on today also, the Petitioner has again chosen not to present during the today' hearing before the Commission.

- 3.1. We note that the present Petition has been filed by the Petitioner for compliance of RPO for FY 2021-22 against the RPO specified by the Commission in the GERC (Procurement of Energy from Renewable Sources) Regulations, 2010 as amended vide GERC (Procurement of Energy from Renewable Sources) (Second Amendment) Regulations, 2018. The Petitioner prayed the Commission to consider its power procurement of Wind energy towards overall RPO obligation of FY 2021-22 specified in the aforesaid GERC RPO Regulations by the Commission.
- 3.2. We note that pursuant to directives of the Commission vide its Daily Orders dated 27.05.2024 and 21.10.2024, wherein directions were given to the Petitioner for inviting comments/suggestions/objections from the stakeholders in the present Petition by issuing public notices in newspaper and accordingly, in compliance thereof, the Petitioner has published the same in 'Divya Bhaskar', 'Kutch Mitra' and 'Times of India' newspapers for inviting the objections and suggestions from the stakeholders in the present Petition. Moreover, the Petitioner has also filed compliance affidavit dated 07.10.2024 in this regard before the Commission on 14.10.2024.
- 3.3. We also note that the staff of the Commission also uploaded the present Petition along with the relevant documents on website of the Commission inviting comments/suggestions from the stakeholders but the office of the Commission has not received any comments or objections or suggestions from any stakeholders in the present matter.
4. In view of the above, we decide to conclude the hearing in the present matter. The matter is now reserved for appropriate order.
