Confirm whether the said decision has been implemented for the instant transmission asset as well as for the other OMs issued earlier by the CTUIL.
- (d) The Petitioner to submit the following information, on an affidavit, within two weeks:
  - (i) Detailed comparison of awarded cost vis-à-vis completion cost.
  - (ii) Provide the activity-wise time delay justification as per the following format:
