## Record of Proceedings

At the outset, the representative of the Petitioner submitted that all requirements in relation to the Petitions have been duly complied with. It was further submitted that, in compliance with the directions issued vide Record of Proceedings dated 20.6.2025, CTUIL has also submitted the requisite details vide its affidavit dated 14.7.2025. He, accordingly, requested to reserve the matter for order.

In response to the specific query of the Commission regarding the planning of the transmission system involved in the present cases, the representative of CTUIL fairly submitted that the instant transmission system has been planned on the potential basis for the prospective green hydrogen/ green ammonia manufacturers in Navinal area and as on date, no application for GNA has been received from such green hydrogen/ammonia manufacturers.

- After hearing the parties, the Commission directed the CTUIL to file the information, on an affidavit, within a week, on the following:
  - a) Although the scheme was recommended by NCT in a meeting held on 22.08.2024, as of now, there is no GNA application for instant augmentation. How would the system be utilised and the transmission charges recovered, in case no GNA application/ limited GNA applications are received from Green Hydrogen/ Green Ammonia developers? or
  - b) The applications are received with an effective date of GNA that does not match the SCOD of the instant transmission system.
- 4. The Commission reserved the matters for orders.
