Record of Proceedings

The representative of the Petitioner submitted that the present Petitions have been filed for the adoption of transmission charges for the Inter-State Transmission System, viz. "Transmission Scheme for integration of Davanagere / Chitradurga REZ and Bellary REZ in Karnataka" (hereinafter referred to as "the Project"), discovered pursuant to the tariff-based competitive bidding process, and for the grant of a transmission licence for establishing the Project. He further submitted that the parties have also filed their compliance affidavits as per the direction of the Commission vide Record of Proceedings for hearing dated 30.5.2025.

2. The representative of the Respondent, CTUIL has submitted that while CTUIL has filed its *affidavit* dated 9.6.2025 furnishing the details of upstream and downstream transmission systems and the connectivity/GNA granted and/or application received at Devangere/ Chitradurga PS & Bellary PS, it may be permitted to file a revised affidavit in this regard. He further submitted that there is no mismatch in the upstream and downstream transmission systems.

- 3. Considering the submission made by the representative of the parties, the Commission directed CTUIL to clarify the following, on an affidavit, within two weeks:
 - (a) As per CTUIL vide affidavit dated 9.6.2025 the details of connectivity granted at Devanagere PS and Bellary PS, wherein, the start date of connectivity is mentioned as 'tentative'. The 'tentative start dates of connectivity' at both Devanagere PS (900MW) and Bellary PS (476MW) is considered prior to the SCOD (21.09.2027) of the instant scheme. Clarify whether the final grant of connectivity has been issued to the grantees at these Pooling Stations, if so, details thereof.
- 4. Subject to the above, the Commission reserved the matters for order.
