Record of Proceedings

The learned counsel for the Petitioner submitted that the instant Petition has been filed for the truing up of the transmission tariff for the 2019-24 period for the 12 transmission elements of Transmission and Distribution System (Series-1, Series-2 and Series-3).

2. None of the Respondents, has filed their replies in the instant matter despite notices.

3. After hearing the learned counsel for the Petitioner, the Commission directed as under:

(i) The Respondents, as a last opportunity to file their replies within two weeks, with an advance copy to the Petitioner, who may file its rejoinder, if any, within a week thereafter.

(ii) The Petitioner to furnish the following information on an affidavit within two weeks, with an advance copy to the Respondents:

(a) The Auditor's Certificate for the ACE claimed in respect of all the assets and ensures that the elements mentioned in the Auditor's Certificate, like Civil Work, transmission line, etc., must be strictly in conformity with the description of the assets mentioned in the CAG depreciation schedule. All the common costs must be apportioned among the depreciable elements as mentioned in the CAG schedule.



(b) Calculation of the Weighted Average Rate of Depreciation (WAROD) for the asset/elements in accordance with the CAG depreciation schedule, along with the linked Excel sheet. All common costs must be apportioned among the depreciable elements as mentioned in the CAG schedule.

(c) Updated CAG depreciation schedule applicable to DVC.

(d) Calculation of the Weighted Average Rate of Interest (WAROI) for each loan used for the computation of WAROI in Form-9C, along with the linked Excel sheet and the bank interest rate certificates.

(e) Detailed scope of work along with a copy of the sanction order and work orders in respect of Element-3 of Series-1 of the transmission assets.

(f) The line length of Element-3 of Series-1 of the transmission assets.

4. Subject to the above, the Commission reserved the order in the matter.
