Record of Proceedings

The representatives for the Petitioner submitted that the Petitioner has filed the revised tariff forms in Petition No. 482/TT/2019 vide affidavit dated 16.6.2025 and in Petition No. 676/TT/2020 vide affidavit dated 14.6.2025 as per the Commission's direction and requested to allow the tariff in the above matters.



- 2. After hearing the representatives of the Petitioners in the aforesaid matters, the Commission directed the Petitioner to furnish, on an affidavit, within one week, the reason for claiming the de-capitalization/Re-capitalization w.e.f. 1.4.2014 against 250 MVA ICT at Moga instead of the actual date of de-capitalization, i.e., 1.7.2013.
- 2. The Commission further directed the Respondents, as a last opportunity, to file their respective replies within two weeks, with a copy to the Petitioner and the Petitioner to file its rejoinder, if any, within two weeks thereafter.
- 3. Subject to the above, the Commission reserved the order in the matters.
