Record of Proceedings

The representative of the Petitioner submitted that the instant Petitions have been filed seeking the adoption of the tariff discovered pursuant to the tariff based competitive bidding process in respect of "Transmission System for evacuation of RE power from the Raghanesda Area of Gujarat – 3 GW under Phase-I" ("the Project") and for the grant of a transmission licence for establishing the Project.

- Considering the submissions made by the representative of the Petitioner, the Commission ordered as under:
 - (a) Admit and issue notice to the Respondents.

- (b) The Respondents to file their reply, if any, within two weeks with a copy to the Petitioner, who may file its rejoinder(s), if any, within two weeks thereafter.
- In Petition No. 724/AT/2025, the BPC is directed to submit the reasons, on an affidavit, within two weeks, for the discovered transmission charges, i.e., Rs. 2328.71 million, being 34.54% lower than the estimated annual levelized transmission charges as per the prevailing CERC norms.
- (d) In Petition No. 725/TL/2025, CTUIL to submit, on an affidavit, within two weeks, the relevant documents vide which the Raghanesda area was declared a potential RE zone.
- 3. The Petitions shall be listed for further hearing on **25.9.2025**.
