**NOTICE OF TENDER**

1. A tender is invited for the work as mentioned in Appendix 'A' to this notice of tender.
2.
  - (i) The work is estimated to cost as indicated in aforesaid Appx 'A'. This estimate, however, is not a guarantee and is merely given as a rough guide and if the work costs more or less, a tenderer will have no claim on this account even if the variation is too much.
  - (ii) The type of tender shall be as mentioned in aforesaid Appx 'A'.
  - (iii) The work is to be completed within a period as indicated in aforesaid Appendix 'A' in accordance with the phasing, if any, indicated in the tender from the date of handing over of the site, which may be on or about two weeks after the date of acceptance of the tender.
3.
  - (i) Normally contractors whose names are borne on the MES approved list for the area in which the work lies and within whose financial category the estimated amount would fall may tender, but in case Term Contracts, contractors in category A to E may tender in case where the tendered amount is in excess of the financial category, whether or not the estimated amount was within the financial category of the contractor, the Accepting Officer reserves the right to accept the tender, in which event the tenderer would be required to lodge "Performance Security Deposit" as notified by the Accepting Officer, in terms of conditions of contracts.
  - (ii) Contractors whose names are borne on the MES approved list of any MES formation and who have deposited standing security and have executed Standing Security Bond, may also tender without depositing Earnest money alongwith the tender and if the Accepting Officer proposes to accept the tender, such tenderer would be required to deposit, "Performance Security Deposit" as notified by the Accepting Officer, prior to or during signing the WO N0-01. Not more than one tender shall be submitted by one contractor or one firm of contractors.
  - (iii) Under no circumstances will a father and his son(s) or other close relations who have business dealing with one another, will be allowed to tender for the same contract as separate competitors. Breach of the this condition will render the tenders of both patties liable for rejection.
4. The GE (AF), MES, Gurgaon will be the Accepting Officer hereinafter referred to as such for the purpose of this contract.
5.
  - (i) Applications for the tender forms must be submitted to the GE (AF), MES, Gurgaon so as to reach his office on or before as mentioned in aforesaid Appendix 'A'.
  - (ii)
    - (a) Invitation of application for issue of tender does not constitute any guarantee for issue of tender to applicant even to enlisted contractors of appropriate class. Issue of tender will be decided based on past track records, financial position, experience of similar works executed by the applicant/Contractor. The Accepting Officer shall consider application received upto date of receipt of applications for issue of tender. The applicant/contractor will be informed regarding non issue of tender without reasons. The applicant/contractor if he so desires may appeal to the next higher Engineering authority with copy to Accepting Officer. No appeal/representation shall be entertained in respect of application for issue of tender as received after the due date of receipt of application/extended date of receipt of application.
    - (b) The decision of the next higher engineer authority shall be final. No applicant/contractor shall be entitled for any compensation whatsoever for rejection of his application.
6.
  - (i) Tender form and conditions of contract and other necessary documents will be issued to approved contractors on or after as mentioned in aforesaid Appendix 'A'.
  - (ii) The appropriate standing security amount for this work shall be as deposited by contractor enlisted in the area in which the work lies for category mentioned in aforesaid Appendix 'A'.
  - (iii) In case of contractor who has not executed the "STANDING SECURITY BOND", the tender shall be accompanied by "Earnest Money" for the amount referred to in the aforesaid Appendix 'A' in the form of deposit at call receipt in favour of GE mentioned in aforesaid Appendix 'A' by Scheduled Bank/or receipted treasury challan, the amount being credited to the revenue deposit of the GE. A contractor who is not enlisted for the area in which the work lies, but whose name is in the MES approved list of any MES formation and who has deposited Standing Security and executed Standing Security Bond, may tender without depositing earnest money alongwith the tender, but if the Accepting Officer decides to accept tender, such tenderer shall lodge Performance Security Deposit as notified by Accepting Officer with the GE (AF) Gurgaon concerned in prescribed form.

- (iv) A contractor who has executed the standing security bound but not for the appropriate category as mentioned above, shall lodge with the Accepting Officer, 'Performance Performance Security Deposit' as notified by the Accepting Officer.
- (v) GE will return the Earnest Money wherever applicable to all unsuccessful tenderers, by endorsing an authority on the deposit receipt for its refund, on production by the tenderer of a certificate of the Accepting Officer that a bonafide tender(vide condition 12 below) was received and all documents were returned.
- (vi) The GE will either return the Earnest Money to the successful tenderer, by endorsing an authority on the deposit receipt for its refund, on receipt of an equal amount of 'Performance Security Deposit' or will retain the same on account of Performance Security Deposit, if such transaction is feasible.
- (vii) Copies of the drawings and other documents pertaining to the work(signed for the purpose of identification by the Accepting Officer or his accredited representative) and samples of materials and stores to be supplied by the contractor will be open for inspection by the tenderers in the office of GE as mentioned in the aforesaid Appendix 'A' during office working hours.
7. (i) The tenderers are advised to visit site by making prior appointment with the GE by giving sufficient time.  
(ii) A tenderers shall be deemed to have full knowledge of all relevant documents, samples, site etc whether he has inspected them or not.
8. Tenders will be received by the GE (AF), MES Gurgaon on the date and time indicated in the aforesaid Appendix 'A'.
9. Any tender which proposes any alternation to any of the conditions laid down or proposes any other conditions of any description whatsoever, is liable to be rejected except in case of special type of works where the contractors is asked to give his own design/drawing and technical data.
10. Tenderers must be in possession of copy of MES Standard Schedule of Rates 2009 Part I and 2010 Part-II.
11. The submission of tender by a tenderer implies that he has read this notice and the conditions of contract and had made himself aware of the scope and specification of the work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him and local conditions and other factors bearing on the execution of the work.
12. Tenderers must be very careful to deliver a bonofide tender or in the alternative, return BLANK TENDER complete with all the documents forming part of the tender, failing which the Accepting Officer, may at his absolute discretion, reserves the right of forfeiting a portion of earnest money, Performance Security Deposit or security bond amount not exceeding Rs 300/- of the sum deposited by the tenderer. A bonafide tender must satisfy each and a very condition laid down in this Notice.
13. Accepting Officer does not bind himself to accept the lowest or any tender or to give any reason for not doing so.
14. The Accepting Officer reserves his right to accept a tender submitted by a public undertaking giving a price preference over other tenders which may be lower as are admissible under the Government policy. No claim for any compensation or otherwise shall be admissible from such tenderer(s) whose tenders may be rejected on account of the said policy.
15. This notice of tender shall from part of the contract.
16. The Court of the place from where tender has been issued alone have jurisdiction to decide any dispute out of or in respect of this tender. After acceptance of tender, condition 72-Jurisdiction of Court of IAFW-2249 shall be applicable

**NOTES: -**

1. In case after opening of Cover 1, the number of MES enlisted contractors of eligible class as well as eligible un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT is less than 7 (Seven), applications in respect of MES contractors of one class below or two classes (in case of remote and difficult areas to be decided as per list circulated by CE Command / ADG) below the eligible class shall also be considered subject to fulfillment of other eligibility criteria given in the NIT. Therefore, MES contractor’s one class below (two classes in case of remote and difficult areas may also bid for this tender. Such contractors (contractors of one/two classes below the eligible class) shall not be considered in case their present residual work in hand is more than FIVE TIMES their present tendering limit. However in case such contractors fulfil the criteria of upgradation to the stipulated eligible class based on past experience of completed works (individual work experience and / or average annual turnover, as applicable) and financial soundness (solvency/financial soundness and working capital), the ceiling of present residual work will not apply and they will be considered for issue of tender. Such bidders shall upload in their Cover-1 bid details related to residual work in hand like details of works in hand showing names of work, names of Accepting Officers, Contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date. Such contractors, if claim to fulfil the criteria of upgradation shall also upload the requisite information/documents in support of upgradation. These details shall be verified by the Tender Issuing Authority from concerned formations in case bids of such contractors are considered for evaluation.

**APPENDIX 'A' TO NOTICE OF TENDER (CONTD--)**

2. In case after opening of Cover 1, the number of MES enlisted contractors of eligible class as well as un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT, are 7 (seven) or more, applications of only those one class below the eligible class bidders shall be considered, who have previously completed similar works satisfactorily and are meeting the criteria of upgradation in respect of past experience of completed works (individual work experience and/or average annual turnover as applicable) and financial soundness (solvency/financial soundness and working capital) as per details given in Manual on Contractors. Therefore such contractors shall upload the requisite information/documents in the Cover-1
3. Unenlisted contractor shall be considered provided he meets the criteria. Foreign firms shall not be eligible for this tender. However Indian Firms having foreign national / Indian nationals staying abroad / Indian national having taken foreign citizenship, as director(s) shall be considered subject to security clearance from the concerned authorities.
4. Contractors enlisted with MES will upload following documents in Cover-I for checking eligibility :-
- Application for tender on Firm's letter head.
  - Enlistment letter issued by the Registering Authority duly renewed for the cycle period in vogue.
  - Scanned copy of DD/Bankers Cheque toward cost of tender and EMD instrument in case SSD bond is not signed at the time of registration.
  - Contractor to upload the scanned copy of Employee's provident fund code number and copy to be submitted offline within 5 days from Bid Submission End date)
  - Contractor not in possession of the EPF Code number shall be disqualified in 'T' bid evaluation and his financial bid shall not be opened.
  - Contractor not in possession of GST registration number shall be disqualified in 'T' bid evaluation and his financial bid shall not be opened. Copy of GST registration number shall be uploaded online and original to be submitted off line within 05 days from Bid submission end date..
  - Any other document required as described in this Appendix.
5. Contractors not enlisted with MES will be required to upload following documents in Cover 1 for checking eligibility :-
- Application for tender on Firm's letter head.
  - Scanned copy of DD/Bankers Cheque toward cost of tender and Earnest Money Deposit (EMD) instrument.
  - Copy of Police Verification Report/Police Clearance Certificate/Character Certificate from the Police Authority of the area where the registered office of the firm is located/notarized copy of valid passport of Proprietor/each Partner/each Director.
  - All documents required for enlistment in MES for the class mentioned in Para 8(b) above as per Para 1.5 of Section 1 of MES Manual on Contracts 2020.
  - Details of works being executed in MES, if any.
  - Contractor to upload the scanned copy of Employee's provident fund code number and copy to be submitted offline within 5 days from Bid Submission End date)
  - Contractor not in possession of the EPF Code number shall be disqualified in 'T' bid evaluation and his financial bid shall not be opened.
  - Contractor not in possession of GST registration number shall be disqualified in 'T' bid evaluation and his financial bid shall not be opened. Copy of GST registration number shall be uploaded online and original to be submitted off line within 05 days from Bid submission end date..
  - Any other document required as described in this Appendix
6. Tenders not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) in Cover-1 shall not be considered for validation of 'T' bid and their Financial Bids will not be opened.
7. Contractors should ensure that their original physical DDs and Earnest Money Deposit (EMD) instruments (as applicable) reach the office of Accepting Officer within 05 days of bid submission end date failing which following action shall be taken :-
- In case of tenders from an enlisted contractor of MES, where scanned copies of requisite DD/Bankers Cheque towards cost of tender have been uploaded in Cover 1 but physical copies are not received within the stipulated period, their financial bids (Cover 2) will be opened. However non-submission of physical copies of cost of tender shall be considered as wilful negligence of the tenderer with ulterior motives and such tenderer shall be banned from bidding for a period of six months commencing from the date of opening of Financial Bid (Cover 2).
  - In case of tenders from unenlisted contractor, where scanned copies of requisite DD/Bankers Cheque towards cost of tender have been uploaded in Cover 1 but physical copies are not received within the stipulated period, their financial bids (Cover 2) will not be opened. Name of such contractors along with complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of Financial bid (Cover 2).
  - In case of tenders from enlisted and unenlisted contractors, where scanned copies of instruments for Earnest Money Deposit (as applicable) have been uploaded in Cover 1 but the same are not received in physical form within stipulated period, such tenders shall not qualify for opening of financial bid (Cover 2).
8. Contractor will not be allowed to execute the work by subletting or through power of attorney to a third party/another firm on his behalf. However a contractor can execute the work through power of attorney to sons/daughters/spouse or Proprietor/Partner/Director and firm's own employees, director, project manager **provided they are not having a separate enlisted firm in MES in their name as Proprietor/Partner/Director.**
9. After opening of Cover 1 and during its technical evaluation, in case any deficiency is noticed in the documents required to be uploaded by the tenderers as per NIT, a communication in the form of e-mail/SMS/Speed Post etc shall be sent to the contractor to rectify the deficiency within a period of seven days from the date of communication failing which their financial bid (Cover 2) shall not be opened and contractor shall not have any claim on the same.

Contd/-

10. Invitation for e-tender does not constitute any guarantee for validation of Technical bid and subsequent opening of financial bid of any applicant/bidder merely by virtue of enclosing DD , Accepting Officer reserves the right to reject the Technical bid and not to open the financial bid of any applicant/bidder. Technical bid validation shall be decided by the Accepting Officer based on eligibility of the firm as per criteria given in this Appendix. Tenderer/bidder will be informed regarding non-validation of his Technical bid assigning reasons therefore through tender evaluation report which shall be uploaded on the website. Such tenderer, if desires, may appeal to the next higher Engineer Authority (NHEA) viz HQ CWE (AF) Gurgaon on e-mail ID [grganaf3-mes@gov.in](mailto:grganaf3-mes@gov.in) with copy to the Accepting Officer on email before the scheduled date of opening of Cover 2. NHEA shall decide the matter within a period of seven working days from the date of receipt of appeal. The decision of the NHEA shall be final and binding. The tenderer/bidder shall not be entitled for any compensation whatsoever for rejection of his bid.

11. In case an unenlisted contractor is already executing works in MES, he shall not be considered eligible for the subject tender if the total value of such works is more than twice the tendering limit of the MES class of contractor for which it is eligible. For this purpose, details of the works being executed by such a contractor shall be uploaded in the Cover-1 of the bid and shall be checked/verified by the Accepting Officer.

12. In case the BOQ is revised through the corrigendum and the bidder has failed to quote on revised BOQ (ie he has quoted on pre revised BOQ), such bid shall be treated as willful negligence by the bidder and his quotation shall be considered non-bonafid. In such cases the lowest tender shall be determined from amongst the valid/bonafide bids only. Accepting Officer may decide whether to re-tender or consider the lowest bonafide tender for acceptance.

13. Revoking the offer or revising the rates upward or offering voluntary reduction by the lowest tenderer after opening of Cover 2 shall be considered as a willful default. For this default a penalty of an amount equal to Earnest Money shall be levied. In case MES enlisted tenderer, earnest money deposited by him shall be forfeited. In case of MES enlisted tenderer having deposited the Standing Security Bond, an amount equal to the earnest money stipulated in the NIT shall be notified to the tenderer for depositing through MRO and consideration of such tenderer in tender evaluation for future works shall remain suspended till the aforementioned amount is deposited in the Government Treasury. No other disciplinary/administrative action shall be taken against such tenderers. In such a situation, the next lowest offer shall not be considered for acceptance. Instead, retendering shall be resorted to in a transparent and fair manner and the defaulting tenderer and his related firm if any, shall not be eligible for this tender in second call or subsequent calls.

13A. Irrespective of whatever is mentioned in condition 19.3 of IAFW-2249 with regard to suspension of tenders on account of non-submission of Performance security, issue of tenders to such tenders shall remain suspended for a period of six month from the date of cancellation of contract under condition 19.3 of IAFW 2249 in case of unenlisted Contractors. In case of MES enlisted contractor, issue of tenders shall remain suspended till deposit of EMD or six month from date of cancellation whichever is later.

14. Tender to related firms shall not be issued simultaneously. Firms shall be termed as related if Proprietor/one or more Partners/Directors are common. Decision of Accepting Officer on issue/deny the tender to any one of the related firms shall be final and binding.
