The company aims to enhance energy efficiency, integrate innovative energy solutions, and contribute to achieving net-zero emissions by promoting clean energy adoption.

Section - II Introduction

1. INTRODUCTION

- i. The Government of India (GoI) has propelled up the solar energy penetration in the energy mix of the country. Government of India, through Ministry of New and Renewable Energy (MNRE) has taken up a target of 500 GW of renewable energy target by 2030,.
- ii. NTPC is India's largest energy conglomerate with roots planted way back in 1975 and having total installed capacity of 83 GW. NTPC has forayed from fossil fuels to renewable energy sources. This diversification will play a major role in lowering its carbon footprint by reducing greenhouse gas emissions.
- iii. NTPC being a leader in the Power Sector, has strong commitment towards Renewable Energy and therefore would be targeting RE market of at least 10% i.e., 23 GW by FY25 and increase its share further to 12-14% i.e. 60 GW by FY32.
- iv. NTPC Green Energy Limited (NGEL), a wholly owned subsidiary of NTPC has been set up as a separate entity by NTPC to accelerate the group's presence in the RE sector. It is envisaged that all future organic additions would take place through NGEL. Therefore, NGEL would target to achieve around 15 GW by FY25 and scale it further to around 44 GW by FY32.
- v. NGEL is also focusing to enable to Govt of India's vision, to decarbonize the farthest part of country. NGEL is planning to install Renewable power project at GNI island.

2. <u>INTENT OF THE EXPRESSION OF INTEREST (EoI)</u>

- i. The purpose of this EOI is to identify the prospective companies capable to Evaluate site, Prepare DPR, & works as EPC to install Renewable energy project (Ground mounted and floating Solar) with BESS along with transmission of power from power plant to sub stations at GNI.
- Broad scope of work with respect to same is following.
 - Study of energy requirement and existing transmission system of island and suggest capacity of renewable energy project and requirement of energy storage.
 - Carry out and provided Detailed Project Report (DPR)
 - Preparation of Technical specification for the project.
 - EPC of Floating Solar and Ground mounted Solar PV project with BESS.
 - Transmission of power from Power plant to existing substations.

- All statuary clearances and approvals shall be obtained by the contractor.
- Expectations from NGEL w.r.t the techno-commercial terms and conditions to install project at Island.
- In this regard, the companies shall be required to come up with a detailed plan and past project experience of establishing of renewable projects wand BESS project.
- Details of the different technologies, Energy storage options, Cost optimization routes, transit options, etc.
