CPWD -6 for E-TENDERING

 Executive Engineer, O/o The Inspector General, SSB, FTR HQ SSB Guwahati, on behalf of President of India, invites online percentage rate e- tenders from "Specialized Agencies" in two bid system for the work: -

"Supplying, installation, testing and commissioning of 15 KWp off grid Solar Power Station each in 04 Border Out Posts (BOPs) i.e BOP Saralpara, BOP Naharani, BOP Dholkhola and BOP Tukrabasti of 6th Bn Hqrs Ranighuli under SHQ SSB Bongaigaon of FTR HQ SSB Guwahati".

In case the last date of submission of bid is extended, the enlistment of contractor should be valid on the original date of submission of bids.

- 1.1 The work is estimated to cost Rs 67,87,593/- only. This estimate, however, is given merely as a rough guide.
- Agreement shall be drawn with the successful bidders on prescribed Form No. CPWD-7, as amended upto last date of submission of bids. Bidders shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
- 3. The time allowed for carrying out the work will be 180 days from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the bid documents.
- 4. The site for the work is available.
- After submission of bid, the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
- While submitting the revised bid, contractor can revise the percentage rate quoted by him any number of times but before last time & date of submission of bid as notified.
- 7. Earnest Money in the form of Demand Draft or Banker's Cheque or Fixed Deposit Receipt (drawn in favour of The Inspector General, FTR HQ SSB Guwahati, payable at Guwahati shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The original EMD should be deposited in the office of Executive Engineer, FTR HQ SSB Guwahati within the period of bid submission.

Certificate of work experience and other documents as specified in the NIT shall be scanned and uploaded to the e-Tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in press notice shall have to be submitted by the lowest bidder only within a week physically in the office of tender opening authority.

Online bid documents submitted by intending bidders shall be opened only of those bidders, whose original EMD is deposited with the office of tender calling authority and other documents scanned and uploaded are found in order.

8. The bid submitted shall become invalid if:

- i. The bidder is found ineligible.
- ii. The bidder does not deposit original EMD and original solvency/ Bank certificate.
- The bidder does not upload all the documents (including GST registration) as stipulated in the bid document.
- iv. If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and the hard copies as submitted physically by the lowest bidder in the office of bid opening authority.
- 9. The contractor, whose bid is accepted, will be required to furnish performance guarantee of 3% (three Percent) of the bid amount within the period specified in schedule F. This guarantee shall be in the form of Banker's cheque of any scheduled bank, Demand Draft of any scheduled bank, Fixed Deposit Receipts or Guarantee Bond of any Scheduled Bank or the State Bank of India. In case the contractor fails to deposit the said performance guarantee within the period as indicated in schedule 'F' including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The earnest money deposited along with bid shall be returned after receiving the aforesaid performance guarantee.

The description of the work is as follows: -

Supplying, installation, testing and commissioning of 15 KWp off grid Solar Power Station each in 04 Border Out Posts (BOPs) i.e BOP Saralpara, BOP Naharani, BOP Dholkhola and BOP Tukrabasti of 6th Bn Hqrs Ranighuli under SHQ SSB Bongaigaon of FTR HQ SSB Guwahati.

Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general they shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

- 10. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without assignment of any reason thereof. All bids in which any of the prescribed conditions is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
- 11. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the bidders who resort to canvassing will be liable for rejection. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
