

**24) The Bid will not be considered valid if: -**

a) The bidder is found ineligible.  
b) The bidder does not deposit **original EMD and original solvency/Bank certificate** before opening of tender.

c) The bidder does not upload scanned copies of all the documents stipulated in the bid document.  
d) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the bidder in the office of bid opening authority.

25) GST or any other tax applicable in respect of inputs procured by the contractor for this contract shall be payable by the contractor and Govt. will not entertain any claim whatsoever in respect of same. However, component of GST at time of supply of service (as provided in CGST Act 2017) provided by the contract shall be varied if different from that applicable on the last date of receipt of tender including extension if any.

26) Tenderer have to submit educational certificate, work experience and undertaking of electrical technical representative in accordance with Clause 36(i) at the time of agreement.
