Record of Proceedings

At the outset, the learned counsel for the Petitioner submitted that the Appellate Tribunal for Electricity (APTEL), vide its judgment dated 4.9.2025, in Appeal No. 233 of 2022, remanded back the Commission's order dated 29.6.2018 in Petition No. 175/TT/2017 for re-determination of tariff for the 2014-2019 tariff period which shall reflect the actual capital cost, legitimate weighted average interest on loan, grossed-up return on equity based on true effective tax rates, and correct useful life of assets.

2. The learned counsel for Respondent No. 12, BRPL, sought time to file its written submissions in the matter.



- 3. After hearing the learned counsels for the parties, the Commission directed the parties to file their respective written submissions, if any, after exchanging copies of the same with each other.
- 4. The Commission further directed the Petitioner to submit, on an affidavit, the following information within a week, with a copy to the Respondents:
 - The Income Tax Returns/Assessment Orders, if any, in sealed envelopes to substantiate the Petitioner's claim for the 2014-19 tariff period.
 - ii. Form 9C indicating all individual loans and the Weighted Average Rate of Interest (WAROI) along with a linked Excel sheet based on the actual loan portfolio for the 2014-19 tariff period.
