**Record of Proceedings**

Petition Nos. 448/TT/2024 and 12/TT/2025 have been filed for the determination of the transmission tariff for the 2019-24 tariff period, while Petition Nos. 372/TT/2024 and 378/TT/2025 have been filed for the determination of the transmission tariff for the 2024-29 tariff period. Petition No. 487/TT/2025 has been



filed for the truing up of the transmission tariff for the 2019-24 tariff period and the determination of the transmission tariff for the 2024-29 tariff period.

2. During the course of the hearing, the Petitioner's representatives briefed about the Petitions and requested that the transmission tariff be allowed as claimed in the respective Petitions.

3. None was present on behalf of the Respondents, despite notice in Petition Nos. 487/TT/2025 and 12/TT/2025.

4. In Petition No. 372/TT/2024, the learned counsel for Respondent No.1, TANGEDCO, urged the Commission to open the portal, enabling him to file a reply on behalf of TANGEDCO. He, however, requested the Commission to permit him to file the reply as it is ready with him.

5. After the hearing, the Commission directed the Respondents to file their respective replies, if not already filed, including TANGEDCO, within two weeks, with an advance copy to the Petitioner, who may file its rejoinder, if any, within a week thereafter.

6. The Commission further directed Respondent No. 16, CTUIL, to submit the following information in Petition No. 438/TT/2025, on an affidavit, with a copy to the Petitioner, within two weeks.

(i) Documents related to the connectivity application for the transmission asset in the instant Petition.

(ii) A copy of the Long-Term Agreement (LTA) for the transmission asset.

7. Subject to the above, the Commission reserved the orders in these matters.
