Record of Proceedings

The present Petitions have been filed for the true-up of the transmission tariff for the 2019-24 period and for the determination of the transmission tariff for the 2024-29 period. During the course of the hearing, the Petitioner's representatives briefed about the Petitions and requested that the transmission tariff be allowed as claimed in the respective Petitions.

2. After hearing the representative of the Petitioner, the Commission directed as under:

- a) Issue notice to all the Respondents.
- b) The Respondents to file their respective replies, if any, within two weeks, with an advance copy to the Petitioner, who may file its rejoinder, if any, within two weeks thereafter.
