(b) having experience as given at (C) (i) below.

(iii) No recovery outstanding in Government Department.

(iv) Not carrying adverse remarks in Work Load Return (WLR) or any other similar report circulated by any competent authority, if already working in MES.

(v) Not suspended / debarred / blacklisted (either permanently or temporarily) from participating in any bid or for business dealings by any Central / State Government Department or any Central / State Government PSU or any Autonomous Body under Central/State Government or any Local Body as on the bid submission end date.

(vi) Details of works completed and under progress in MES be submitted in the following format:-

(vii) Un-enlisted Contractor who have secured two works in MES should get themselves registered in the appropriate designated Class with any Registering Authority, else the firm will not be eligible for participation in the tender unless until the firm is enlisted with the MES.

(i) Experience of having successfully completed Solar Power Plants in Government Department/ PSU during last seven years ending last day of the month previous to the one in which applications are invited should be any of the following :-

a) One work of capacity > 80% of capacity of plant Specified in NIT
(or)

(b) Two works of capacity > 50% of capacity of plant Specified in NIT
(or)

(c) Three works capacity > 40% of capacity of plant Specified in NIT

			<p>(ii) Contractor will not be allowed to execute the work by subletting or through power of attorney holder on his behalf to a third party/ another firm except sons/ daughters of proprietor/partner/ Director/ Project Manger as per contract conditions.</p> <p>(iii)</p> <p>(a) In a tender, the eligible solar power firm can either bid as direct participant/ bidder or under MoU with MES enlisted/ un-enlisted contractor, but cannot bid simultaneously for the same tender as direct participant/ bidder as also under MoU with MES enlisted/un-enlisted contractor.</p> <p>(b) MoU will be permitted between only one eligible solar power firm and one MES enlisted/ un-enlisted contractor, bidding for the same tender.</p> <p>(c) In case any violation of condition at (iv) (a) & (b) above is noticed, all such bids shall be treated as invalid.</p>

Notes: -

- After opening of Cover-I, if the number of MES enlisted contractors of eligible class as well as eligible un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT are less than 7(Seven), applications in respect of MES contractors one class below the eligible class shall also be considered subject to fulfilment of other eligibility criteria given in the NIT. Therefore, MES contractors one class below may also bid for this tender. Such contractors of one class below the eligible class shall not be considered in case their present residual work in hand is more than FIVE TIMES their present tendering limit. However, in case such contractors fulfil the criteria of upgradation to the stipulated eligible class based on past experience of completed works (individual work experience and/or average annual turnover, as applicable) and financial soundness (solvency/ financial soundness and working capital), the ceiling of present residual work will not apply and they will be considered for issue of tender. Such bidders shall upload in their Cover-1 bid details related to residual works in hand like details of work in hand showing names of work, names of Accepting Officers, contact details of Accepting Officers, Contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date. Such Contractors, if claim to fulfil the criteria of upgradation shall also upload the requisite information/ documents in support of upgradation. These details shall be verified by the Tender Issuing Authority from concerned formations in case bids of such contractors are considered for evaluation.
