M.P. Power Transmission Company Limited, Jabalpur (MPPTCL) has filed the Petition for approval for Transmission system strengthening works in Sabalgarh area, including construction of 400 KV substation at Sabalgarh by MPPTCL through regulated Tariff Mechanism (RTM). The instant petition has been filed under the provisions of Regulation 2 of MPERC (Terms and Conditions for Determination of Transmission Tariff) (Revision – V) Regulations, 2024 {RG-28 (V) of 2024} and its amendment.
