

- ii) If any tenderer withdraws his tender after expiry of 7 days after last date and time (24 hrs. basis) of submission of bids, then the Institute shall without prejudice to any other right or remedy, be at liberty to forfeit 100% of the earnest money absolutely irrespective of letter of acceptance for the work is issued or not.
- iii) Withdrawal of the tender, by the bidder, shall only be made through e-tender portal. Any other method i.e. through letter/e-mail etc. shall not be considered. The tender inviting authority gets intimation through SMS and e-mail in this regard.

20. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of:

- (i) The notice inviting tender, all the documents, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof, together with any correspondence leading thereto.
- (ii) Standard C.P.W.D. Form as mentioned in Schedule 'F', consisting of:
  - a) Various standard clauses with corrections up to the date stipulated in Schedule 'F', along with annexures thereto.
  - b) C.P.W.D. Safety Code.
  - c) Model Rules for the protection of health, sanitary arrangements for workers employed by CPWD or its contractors.
  - d) CPWD Contractor's Labour Regulations.
  - e) List of Acts and omissions for which fines can be imposed.
- (iii) No payment for the work done will be made unless the contract is signed by the contractor.
- (iv) In the case of Percentage Rate Tenders, only the percentage quoted shall be considered.
- (v) Tenderer must ensure to quote the percentage rate. The column meant for the quoting rate in the figure appears in yellow, and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells, a warning appears that if any cell is left blank, the same shall be treated as '0'. However, if a tenderer quotes nil rates against each item in an item rate tender or does not quote any percentage above/below on the total amount of the tender or any section/subhead in a percentage rate tender. The tender shall be treated as invalid and will not be considered as the lowest tenderer.
