**Record of Proceedings**

At the outset, the learned senior counsel for the Petitioner, RSDCL, sought two weeks' time for placing on record certain additional issues, including the reasons attributable to the delay in the commissioning of the Solar Park and relevant supporting judgments thereof. He further apprised that the Respondent, NTPC, has now commissioned the balance 78 MW capacity; however, certain minimum formalities are required to be completed and the actual commissioning date has to be ascertained. Accordingly, he requested one more effective hearing in the matter.

2. Learned senior counsel for the Respondent, NTPC, did not oppose such a request of the Petitioner. While confirming that NTPC has achieved the balance commissioning of 78 MW capacity on 18.12.2025, he also submitted that the Petition was filed by RSDCL only to seek an extension of time for connectivity and the start date of LTA, and as such, no relief has been claimed against NTPC in the present Petition.



3. Learned counsel for the Respondent, CTUIL, submitted that NTPC has completed its part of the commissioning, however, no certificate pertaining to Date of Commercial Operation (DOCO) has been received so far.

4. Learned counsel for the Respondent, Rising Sun Energy (K) Private Limited (RSEKPL), submitted that its 190 MW capacity was ready for commissioning in October 2022, but the commissioning was delayed due to non-readiness of the Solar Park. He further submitted that while NTPC has released the Performance Bank Guarantees (PBGs) furnished by RSEKPL, subject to furnishing an undertaking, RSDCL continues to withhold its PBGs, citing the pendency of the present matter.

5. Considering the request of learned counsel for the Petitioner, the Commission permitted the Petitioner to file its additional affidavit in the matter within two weeks with a copy to the Respondents, who may file their respective response to the same, if any, within two weeks thereafter.

6. The Petition will be listed for the hearing on **17.2.2026**.
