Record of Proceedings

The learned counsel for the Petitioner submitted that the present Petitions have been filed for the grant of a transmission licence to establish the inter-State transmission system, viz., "Transmission System for Integration of Ananthapuram-II REZ – Phase II (3 GW)" ('the Project') and for the adoption of transmission charges in



respect of the Project as discovered pursuant to the tariff-based competitive bidding process. The learned counsel further submitted that the Petitioner has also duly complied with all the requirements under the Transmission Licence Regulations, and CTUIL has already issued its recommendations for the grant of a transmission licence to the Petitioner company.

2. Considering the submissions made by the learned counsel for the Petitioner, the Commission directed as under:

- (a) The Petitioner to implead all Southern Region beneficiaries, as may be indicated by CTUIL, as parties to the Petition and file a revised memo of parties within a week.
- (b) Admit and issue notice to the Respondents, including the impleaded Respondents as above; and
- (c) The Respondents to file their respective replies, if any, within a week with a copy to the Petitioner, who may file its rejoinder(s), if any, within a week thereafter.

3. The Petitions will be listed for hearing on **23.12.2025**.
