Record of Proceedings

The matter was called out for a virtual hearing.

2. During the course of the hearing, the representative(s) of the Petitioner submitted that all the requisite information sought in the Petition has been filed along with affidavits.
3. Respondent No. 1 (MPPMCL) requested the reopening of the e-filing portal to submit its reply.
4. Respondent No. 2 (MSEDCL) sought two weeks' time to file a reply in the matter.
5. After hearing, the Commission directed as under:
 - i) The Respondent(s), including MSEDCL & MPPMCL, to file their respective replies, within two weeks, with an advance copy to the Petitioner, who may file its rejoinder, if any, within a week, thereafter.
 - ii) CTUIL is directed to furnish the following information on an affidavit, within two weeks, with an advance copy to the Petitioner:
 - a) Whether completion and/or availability of any pre-required and/or associated transmission elements was a prerequisite for claiming deemed COD of the instant transmission asset?
 - b) The basis under which CTUIL approved the deemed COD of the transmission asset(s) covered under the instant Petition, without the commissioning of the 765 kV Navsari Sub-station?
 - c) Whether the transmission assets covered under the instant Petition can serve their intended purpose without the commissioning of the 765 kV Navsari (New) - Padghe line, the 765 kV line bays at Navsari (New), and the 765 kV ICT bays at the Navsari Sub-station (New)?
6. The Petition will be listed for further hearing on **19.3.2026**.
