1. Introduction

FCI Aravali Gypsum and Minerals India Limited (FAGMIL), a Government of India enterprise under the Department of Fertilizers, is diversifying into the renewable energy sector as a Solar Power Generator. In line with national priorities on sustainable development and green energy, FAGMIL intends to develop a **2.52 MW AC solar power plant** at Bhawad, Jodhpur, under a **Build-Own-Operate (BOO)** framework.

This EOI invites experienced and qualified solar developers to design, finance, construct, commission, operate, and maintain the plant for a period of **25 years**, with compliance of all role and responsibility of FAGMIL under PPA reference no. **RUVITL/SE/PP/F./D.520** dated **12.06.2025** (**Appendix-I**) & LoA reference no. **JDVVNL/CE(HQ)/SE(RA&C)/RE-DSM/TN-DSM-50/LOA No. 178/D.4081** dated **15.03.2024** (**Appendix-II**).

2. Background and Objective of the EOI

India is running one of the world's biggest renewable energy transition program, in order to fight climate change, the Prime Minister has also pledged to increase the country's renewable energy capacity to 500 GW by 2030.

Against the LoA of JDVVNL reference no. **JDVVNL/CE(HQ)/SE(RA&C)/RE-DSM/TN-DSM-50/LOA No. 178/D.4081** dated **15.03.2024** FAGMIL has been awarded PPA reference no. **RUVITL/SE/PP/F./D.520** dated **12.06.2025**. As per the clause no. **5.1.5** of PPA the last date of project completion was **31.12.2025**. This EOI is for intend to engage a developer BOO basis with specific Scope of Work to get into the PPA execution period.
