### PRESS NOTE

#### Truing-up of the Retail Supply Business for the Fourth Control Period (FY 2019-20 to FY 2023-24)

The AP Electricity Regulatory Commission (APERC), Kurnool, today issued an Order on the Truing-up of the Retail Supply Business for the Fourth Control Period (FY 2019-20 to FY 2023-24), disposing of OP Nos. 33, 35 and 36 of 2025 after carefully considering all public objections, views, and suggestions. 1. The true-up and carrying cost claimed by the APDISCOMs for the 4th Control Period are shown in the table below.

It is noted that the Government of Andhra Pradesh, vide letter No.ENE01/872/2025-POWER I dated 31.12.2025, has undertaken to pay the DISCOMS the true-up amount to avoid hardship to end consumers and to keep its commitment to the people not to burden them with electricity charges. Hence, the Commission directed the DISCOMS to claim the approved true-up amounts, as shown in the above table, from the Government of Andhra Pradesh.
