Record of Proceedings

Learned counsel for the Petitioner submitted that the present Petition has been filed seeking adoption of tariff discovered through the transparent, competitive bidding process conducted by the Petitioner under RfS for supply of 6000 MWh (1500 MW x 4 hours) Assured Peak Power from ISTS- connected Renewable Energy (RE) Power Projects with Energy Storage System (ESS) anywhere in India as per the "Guidelines for Tariff Based Competitive Bidding Process for Procurement of Firm and Dispatchable Power from Grid Connected Renewable Energy Power Projects with Energy Storage Systems" dated 9.6.2023 read with subsequent amendments thereto as issued by the Ministry of Power, Govt. of India.

2. Considering the submissions made by the learned counsel for the Petitioner, the Commission directed as under:

- a. Admit and issue notice to the Respondents, subject to just exceptions.
- b. The Respondents to file their respective replies, if any, within two weeks, with a copy to the Petitioner, who may file its rejoinder within a week thereafter.



- c. The Petitioner to file, on an affidavit, within two weeks, a copy of the conformity certificate pertaining to the justification of the higher tariff identified during the bidding process that the same aligns with the prevailing market prices.
 - d. The Petitioner to file a brief note indicating the competitiveness of the tariff discovered in this case vis-à-vis the tariff discovered in contemporaneous tenders having similar key features, e.g. minimum Availability during Peak Hours, etc.
3. The Petition will be listed for hearing on **24.2.2026**.
