**Record of Proceedings**

The present Petitions have been filed for the determination of the transmission tariff from their respective commercial operation dates (CODs) to 31.3.2029. During the hearing, the Petitioner's representatives briefed on the Petitions and requested that the transmission tariff be allowed as claimed in the respective Petitions.

2. In response to a query of the Commission in Petition No. 533/TT/2025, the Petitioner's representative submitted that the Petitioner has replied to the Technical Validation letter and information sought through Record of Proceedings dated 22.12.2025. He further submitted that none of the Respondents has replied in this matter.



3. In Petition No. 563/TT/2025, 730/TT/2025 and 729/TT/2025, the representatives of the Petitioner submitted that none of the respondents has filed any reply in these Petitions. They further submitted that the Petitioner has filed replies to the Technical Validation Letter and Record of Proceedings.
