Record of Proceedings

The Petitioner's representatives submitted that these Petitions have been filed to true up the transmission tariff for the 2019-24 period and to determine the transmission tariff for the 2024-29 period.

2. The Petitioner's representative submitted that an amended Petition has been filed in Petition No. 529/TT/2025.

2. After the hearing, the Commission directed as under:

- a) Issue notice to the Respondents in Petition No. 602/TT/2025 and notice of the amended Petition to the Respondents in Petition No. 529/TT/2025;
- b) The Respondents to file their respective replies, if any, within a week, with an advance copy to the Petitioners, who may file its rejoinder, within a week thereafter.

3. The Commission further directed the Petitioner to submit the following information in these Petitions, on an affidavit, with a copy to the Respondents, within two weeks:

In Petition No. 602/TT/2025

- i. Form 7(B) and Form 4(B) for the transmission project.
- ii. Liability Flow Statement in Excel format, reconciling it with the Additional Capital Expenditure (ACE) claimed.
- iii. Tariff forms in Excel format, as the uploaded tariff forms do not match the claims as per the Petition.

In Petition No. 529/TT/2025

- i. Re-submit Form 10(B), clearly mentioning the date of de-capitalisation of the assets.
 - ii. Form 4(B).
 - iii. Liability Flow Statement in Excel format, reconciled with the ACE claimed.
4. The Petitions will be listed for hearing on **27.2.2026**.
