**Subject** : Petition under Section 62 read with Sections 79(1)(c) and (d) of the Electricity Act, 2003, read with Regulation 15(1)(a) of the Central Electricity Regulatory Commission (Conduct of Business) Regulations, 2023, Regulation 27(1)(c)(i) of the Central Electricity Regulatory Commission (Indian Electricity Grid Code), Regulations 2023 and the applicable provisions of the Central Electricity Regulatory Commission (Terms and Condition of Tariff Regulations), 2024 for determination of transmission tariff from COD to 31.3.2029 for the Transmission System of Kallam Transmission Limited in the Western Region.

**Record of Proceedings**

The present Petition has been filed for the determination of transmission tariff for the implementation of 1 No. 400 kV bay at Kallam PS for the interconnection of the RE project of Torrent Solar Power Private Limited from COD to 31.3.2029 under the Regulated Tariff Mechanism (RTM) project.

2. The learned counsel for the Petitioner requested the Commission to allow the tariff in respect of the transmission asset in the Petition.
3. After the hearing, the Commission directed as under:
  - a) Issue notice to all the Respondents.



b) The Respondents to file their respective replies, if any, within two weeks, with an advance copy to the Petitioner, who may file its rejoinder, if any, within one week thereafter.

4. The Commission further directed the Petitioner to submit the following information, on an affidavit, with a copy to the Respondents, within two weeks:

- a) Clarification regarding the mismatch between the capital cost claimed in the Petition and the capital cost claimed in the Auditor's Certificate.
- b) Clarification on the mismatch between the equity contribution claimed in the Petition and in Tariff Form-8.
- c) Supporting documents for the tax rate claimed for the purpose of grossing up of ROE.
- d) Reasons for availing a loan from the parent company (Infrastructure Investment Trust) instead of a bank or any other financial institution.
- e) Legible copies of the Tariff Forms 2 and 5, as the submitted copies are not legible.
- f) Liability Flow Statement in respect of ACE for the 2024-29 tariff period.
- g) Details of works asset-wise/ work-wise included in the original scope of work, along with estimates of expenditure, liabilities recognised to be payable at a future date, and the works deferred for execution, against which the Petitioner has projected the Additional Capital Expenditure (ACE) for the 2024-29 tariff period.
- h) Assessment of security requirements for the 2024-29 tariff period.

5. The Petition will be listed for hearing on **19.3.2026**.
